Policy Letter 2023

It is your responsibility to notify us either before or as grain is delivered of the disposition (storage, contract, etc.) of your grain and the farm and/or splits. Please check every ticket immediately. Please tell us when the farm is finished so that we can get final information out to all parties involved.

Our Policy on applying bushels at harvest:

FIRST: We apply bushels to contracts.

SECOND: We put grain into storage if you have NO contracts or have NOT given us any other instructions.

THIRD: If you have NO contracts (or if they are filled), and have requested NOT to store grain, we will buy our grain at the close of the day it is delivered. (Spot Sale). Weekend deliveries will be priced on Mondays close.

When there is a Board of Trade Holiday, the grain will be priced on the close of the next market day unless otherwise instructed.

Persons who sell grain, put grain on a price later, or store grain with us are protected by provisions contained in the Illinois Grain Insurance Act. Charges on any grain delivered prior to fall of 2023 that remains in our facilities and has not been prepaid, will be due and payable August 31, 2023. ALL old crop grain in our facilities past August 31, 2023 will be subject to the applicable minimum storage charge or service charge rate. If producers sell for Fall delivery and wish to carry money forward, we will send you a copy of your grain sheet showing money due you and make payment in 2024 or whenever you wish.

Note: You will have 3 days from the date of unload to determine how to handle your grain.
