2025 Fall Corn Policy

- Sell or Contract corn will be dried to 15% moisture. Shrink will be 1.4% per point down to 15%. DP corn will be dried to 14%. Shrink will be 1.4% per point down to 14%.
- Customers must specify at time of delivery if they want grain to be applied to contract, sold (spotted) or placed into Delayed Pricing (DP). No warehouse receipts will be issued. All unspecified bushels will be placed under Delayed Pricing.
- Delayed Pricing (DP) is not storage. We do not offer storage. Grain cannot be taken back out. Delayed Pricing is hauling in to the elevator, but not setting a price on it. Price can be placed/determined anytime markets are open. See below for Delayed Pricing fees.
- Service fees for Delayed Pricing corn from start of harvest to January 31, 2026 will be \$.20 per bushel. Minimum fee is \$.20 per bushel. Commencing on January 31, 2026, service fees for Delayed Pricing will be charged at the rate of \$.05 per bushel per month. When Delayed Pricing crop is sold, service charges will be deducted.
- If old crop corn remains in Delayed Pricing on July 31, 2026, the customer will be billed for service fees owed and if applicable any outstanding drying charges. The customer will not be forced to sell the crop on Delayed Pricing; just will need to pay service fees and outstanding drying fees if applicable, due within 30 days to avoid finance charges. Customer will get a statement in the mail after July 31, 2026 that will tell them what is owed on service fees and other applicable fees as of July 31, 2026.
- Drying charges
 - No minimum drying charges will apply.
 - O Drying from 17% on down will be charged at the rate of \$.0550/BU per point, broken out in half point increments.
 - O Drying from 17.1% to 20% will be charged at the rate of \$.0450/BU per point, broken out in half point increments.
 - O Drying from 20.1% and above will be charged at the rate of \$.0400/BU per point, broken out in half point increments.
