Our records indicate that last year from June 1, 2022 through May 31, 2023 you purchased gallons of propane from Synergy Cooperative.

- Accounts must be current upon enrollment.
- The pre-buy programs offer a fixed price. Prices will not go down if the markets go down.
- Pre-Buy contract deliveries will begin on October 1, 2022 and will end April 30, 2023.
- Propane gas that is delivered after April 30, 2023, or in excess of the pre-buy gallons will be billed at the daily retail price.
- The contract and the pre-buy amount due must be received in our office prior to the due date to guarantee the stated price offer.
- The minimum gallons for a pre-buy contract will be 300 gallons. In the event that a customer has a prior contract for the current year and is contracting additional gallons, we will accept less than 300 gallons.
- All contract plans are non-transferrable to other accounts or locations.
- Contracted gallons will be delivered from the first contract through the last if multiple contracts are purchased.
- Patron must have an approved charge account to be eligible for the Deposit Contract.
- If contracted gallons do not cover the entire delivery, a minimum of 200 gallons, or filling the tank to 80% is required.
- All unused dollars at the end of the contract period will remain in a prepaid account. Gallons and price lock will be void.
- Late returned contracts will be subject to a price increase based on the current market replacement cost.
