



GRAIN POLICY

1. When unloading grain, the **driver** is responsible to communicate:
 - a) Who **hailed** the grain
 - b) Who **owns** the grain
 - a. Is the grain **spot** (Cash or Deferred)
 - b. Is the grain **contracted** (Fixed, HTA, Basis, Delayed)
 - c. Is the grain **stored** (Grain Bank)
2. Spot Grain
 - a. **Unpriced grain received before 1:00pm will be priced at the market closing price that day.**
 - b. **Unpriced grain received after 1:00pm, or on days the market is closed, will be priced at the market closing price the next day the market is open.**
3. Grain Bank storage is calculated per day at a rate of \$.00131416 (\$0.04 per month) for corn and soybeans.
 - a) Grain Bank deficiencies are not allowed and will be billed monthly based on the price the day of the shortage.
 - b) \$0.02 per bushel discount on Grain Bank grain (corn or soybeans) used in a feed mix
4. Handling Charges
 - a) **Corn, Wheat, Oats** – no in-charge
 - b) **Soybean in-charge** – \$.06 per bushel, unless sold at time of delivery
 - c) **Out-charge for all grain** – \$.10 per bushel, unless used in Synergy feed mixes or marketed through Synergy
5. Corn Moisture
 - a) Corn **over 28% moisture** subject to rejection. Please call ahead to make arrangements.
 - b) No corn **over 32% or under 48 lb.** test weight will be accepted for drying or storage
6. Soybean Moisture
 - a) Soybeans accepted up to 14% moisture
 - b) Soybeans over 14% subject to rejection
 - c) Soybeans over 15% will have a moisture charge
 - d) Late season drying available as seen fit if inclement weather persists
7. Wheat Moisture and Quality (Almena, Accepted at Harvest Only)
 - a) Wheat over 13.5% will have a moisture charge
 - b) Wheat over 16.5% subject to rejection
 - c) Wheat under 300 falling number subject to rejection
 - d) Grain bank is not available for wheat. Contract or cash price only.
8. Rice Lake accepts dry grain only (corn 14.5% and below, soybeans 13% and below)
9. Discounts will be taken for foreign matter, damage and test weight.
10. Due to volatile fuel prices, drying surcharges may fluctuate depending on fuel prices at the time of drying.
11. Synergy maintains a **zero tolerance for treated soybeans.** Any delivery which yields a sample containing treated soybeans may be subject to one or all of the following:
 - a) No payment for the entire load
 - b) **Punitive charges for contamination of all affected soybean inventory**
 - c) Further financial liability dependent on severity of contaminated soybeans
12. **Cameron location traffic policy:** All grain traffic entering and leaving property must do so by way of County Road SS to the east.
13. We reserve the right to direct grain to any of Synergy's elevators or feed mills depending on storage and quality.
14. We reserve the right to refuse grain based on quality and available storage.
