CHARGE ACCOUNT AGREEMENT

THIS AGREEMENT is made and entered on the above stated date by the said Credit Patron(s) and *Trinity Ag, LLC* (the "Company") and, to the extent applicable, pursuant to the Consumer Credit Protection Act (Federal Truth in Lending Act, 15 U.S.C. § 1601 et seq. as amended) and the Kansas Uniform Consumer Credit Code (K.S.A. 16a 1-101 et seq. as amended)

If this agreement is approved by Trinity Ag LLC, it shall allow the credit customer to purchase goods and services on credit and the credit customer agrees to pay for any goods and services in accordance with this agreement.

- All purchase(s) made on credit during the month that are reflected on the periodic billing statement for such month are due and payable by the 15th of the month following purchase.
- If all purchases are paid in full before the 30th day of the month following the month of purchase, the account shall not be subject to finance charge.
- Any balance not paid before the 30th day of the month following the month of purchase, shall be subject to a finance charge of 1.2% per month which is an annual percentage rate of 14.4%, said finance charge to apply to the unpaid balance on the account on the last day of billing cycle carried over from the prior month, and the minimum amount of such charge shall be \$.50 per month.
- Trinity Ag LLC reserves the right to terminate credit sales to the customer at any time without prior notification, and in addition thereto, no additional credit purchases will be allowed to any account that is over 30 days past due.
- This agreement may be changed by Trinity Ag LLC to increase the finance charge, change the due date, change the billing cycle, change the method of calculating the finance charge or change matters of similar nature within the limitations of applicable law. Notice of any such change shall be given to the customer 30 days prior to the effective date of change.
- Credit customer agrees to pay the reasonable costs of collection including, but not limited to, attorney and collection agency fees (but not both), and the court costs, but such fees may not exceed 15% of the unpaid debt after default, in accordance with K.S.A. 16a-2-507, as amended. Until notified in writing to the contrary by the customer, Trinity Ag LLC may assume that the customer's spouse, children over the age of sixteen years, and employees, if any, are authorized to purchase goods or services and charge them to the customer's account.
