

2025 Wheat Harvest Policy

June 27th, 2025

Soft Red Wheat

Contracted Grain

- Grain will be applied to contracts before selling, unless cleared by management.
- Once contracts are filled, grain will be enrolled in Delayed Price, unless otherwise noted by the customer.
- If grain is delivered to a location other than the location specified on the contract there may be a price adjustment made to loads.

Cash Settle Gain

- All grain sold across the scale will be priced at that day's closing bid, established at the closing of that day's CME trading session. If there is no market trade that day, the session close prior to that day will be used.

Safety Tips

- Do not use cell phones at the dump pit.
- Do not begin hoisting dump bed vehicles until instructed to do so.
- Do not proceed back to the scale until the operator signals you to do so.

Delayed Price (DP)

- 8 cents/bushel/month . Prorated daily. Refunded if priced in 7 calendar days. No Drop Charge.

Open Storage

- 15 cents drop charge/bushel & 10 cents/bushel/month.

Mycotoxin Testing Procedures

- We reserve the right to test daily composite samples by field.
- Please inform graders when you change fields.
- Results will be posted within 24 hours or less.
- You do have the right to have each of your loads tested individually for mycotoxins before dumping.

SHRINK AND DISCOUNT SCHEDULE
EFFECTIVE June 27, 2025

Base grade #2 Soft Red Winter Wheat: 58 Test Weight, 13.5% Moisture, 4% Damage, 1% Foreign Material, 5% Shrunk and Broken Kernels, 5% Total Defects, 5% Other Classes of Wheat 60 lbs. Equals one dry bushel. Drying charges and all other discounts (except dockage) will be calculated on the dry, clean bushels per load.

The entire amount of dockage will be deducted from gross bushels. Dockage is calculated in 0.1% increments.
