Provide sufficient bunk space so all cattle can eat at the same time. Cattle should have access to fresh, clean water at all times.

# **Usage Tips**

SteakMaker Grower 38-0 (VP) is a protein, mineral and vitamin supplement for growing or backgrounding cattle fed a moderate to high forage based ration This supplement is typically fed at 1.0 to 2.0 lb/h/d depending on the nutrient profile of other ration ingredients, ration energy content, age and size of cattle being fed and the medicated option used. Typically, rations with some alfalfa or barley will need only 1.0 lb/h/d, but rations with corn, milo, silage, and grass hay may need a higher level of supplementation.

SteakMaker Grower 38-0 (VP) can also be fed in combination with NPN containing liquid supplements to build growing rations with the conditioning benefits of liquid while formulating for optimal levels of NPN and natural protein.

All ration adjustments should be made on a gradual basis. Use good bunk management techniques and procedures to prevent digestive disturbances and optimize dry matter intake and animal performance. Medicated SteakMaker Grower 38-0 (VP) supplements should be thoroughly mixed with grain and roughage. Follow label directions for mixing instructions.

For best results, a feeding program using Land O'Lakes Farmland Feed beef ration balancing program(s) should be developed.

#### **Key Points**

- 1. The amount of ration consumed should be considered in determining the proper level of additives to be fed.
- 2. Ideal for moderate to high forage growing and backgrounding rations.
- 3. A highly palatable supplement with no added urea. Ideal for young calves and situations where producers prefer not to use any urea or animal protein containing supplements.
