TERMS: Terms of the sale are cash unless other arrangements are made with the individual before the sale. The auctioneer will settle any disputes as to bids. Each animal will be sold to the highest bidder without reservations, will be the property of the purchaser and at the purchaser's risk as soon as sold, and can be moved after settlement is made.

REGISTRATION CERTIFICATES: All consignments are registered in the Herd Book of the American Red Poll Association. Certificates of registration will be furnished with transfers recorded, free of extra costs to the buyers upon sufficient payment of the lot.

HEALTH PAPERS: All cattle will have health papers required by the State of **Tennessee**. Some states require permits and some Trichinosis tests. The American Red Poll Association encourages consignors to have fertility tests and Trichinosis tests performed on all bulls over 1 year of age. A Veterinarian will be on hand to re-issue health papers. It is advisable to know your own state's health requirements on bringing cattle in from out of state.

CONSIGNOR'S RESPONSIBILITY: The seller is the responsible party for all representations made about his cattle. The management of the sale assumes no liability, legal or otherwise, but will endeavor to protect the interest of both the buyer and seller. **Please note that there will not be any "no-sale" statements allowed while the animal is being bid on or afterwards. It is the consignor's responsibility to make arrangements to ensure that any minimum amount desired is obtained through the bidding process.**

GUARANTEE: This sale will be conducted under the Red Poll Breeding Guarantee as noted at end of catalog.

LIABILITY: The Sale Facility and the American Red Poll Association act as sale agents only for the consignors of this sale and assume no liability as to accidents to or by any animal. The guarantees given above are made by each consignor for his own animals which are selling.

A. Breeding Guarantee

2. Proper care must be given by the purchaser to protect breeding qualities and health of guaranteed animals.

B. Bulls

 - b. Or allowed to run with the herd until 20 months of age.

C. Females

1. All females over 14 months of age, sold open, are guaranteed open and breeders.

 - b. Heifers under 14 months of age are to be open, and, if in calf, shall be reported promptly to the seller.
2. Females sold as bred animals, but not in calf, must be reported to seller within 3 (three) months of sale date.
3. Females bred within less than 8 (eight) months prior to date of sale are not guaranteed to be in calf but are guaranteed breeders.
4. Heifers under 8 (eight) months of age are not guaranteed breeders if sold at sides of dams.

D. Adjustments

1. Seller may replace animal in question with another of equal value at time of purchase to the satisfaction of the buyer.
2. Or seller may refund purchase price. No interest, feed, transportation or fees to be charged to seller, Salvage goes to seller.
3. Seller may elect retrial period not to exceed 6 (six) months.
