VII. EVOLUTION OF DESIGN CONCEPTS

Please describe the genesis of the project, through programme, design and construction to final and present occupancy.

Karachi was the Capital of Pakistan but had the disadvantages of a severe climate and being bordered to the north by a vast desert. The Pakistan Government wisely decided to construct a new capital city, bordering the Margala Hills, which are the foothills of the Himalayas. The elevation of the site of the city is some 4,000 feet above sealevel and it has a far more equitable climate than Karachi.

Doxiadis Associates, International Town Planners, were commissioned to design the Master Plan and shortly after the Capital Development Authority had been established, Derek Lovejoy and Partners, then Derek Lovejoy and Associates, were approached and commissioned to carry out all of the environmental planning of the new capital city. This involved working in very close association with not only the staff of the Capital Development Authority but also the many other international consultants who were called in to design various aspects of the scheme.

Derek Lovejoy and Partners were responsible for the design of all of the landscape treatment surrounding the major government buildings, the State Guest House, all of the roads and industrial areas, neighbourhood centres, all housing projects, local, regional and national parks, including the Atomic Energy Research Centre. Derek Lovejoy and Partners prepared some 4,500 drawings and a great deal of the work prepared during that consultancy is still in the course of construction.

VIII. SIGNIFICANCE OF PROJECT

In what way is this project important?

The decision to build a new capital city was one of the most important decisions made by the Government of Pakistan after the partition of India in 1947. New Delhi was the capital of the Indian Empire and after partition, Pakistan was left without a capital. Karachi was the largest and most significant town in Pakistan but this was unsuitable for development as an expanding new capital because of climatic and other circumstances. It was, therefore, decided by the (late) President, Ayub Khan, to build a new city in the foothills of the Himalayas, where the climate was more equitable and the new city could be designed in accordance with Islamic principles and culture.

Derek Lovejoy and Partners made a broad study of the religious, historic and cultural background of the Islamic environment in Pakistan, in order that its national character would be conserved for all time. Derek Lovejoy and Partners are proud to be associated with the development of this city.

During our consultancy, Mr. Derek Lovejoy made more than forty visits to Pakistan and our office, at first based in Rawalpindi and then Islamabad, was in constant operation for nine years with a resident staff, who assisted in the supervision and implementation of the designs. Derek Lovejoy and Partners' consultancy terminated in 1970, after we had had sufficient time to train Pakistan nationals as landscape architects to carry on the task that we had started.
