EYE AND EAR PROTECTION IS REQUIRED AT ALL TIMES ONCE YOU HAVE

ENTERED THE SPORTING CLAYS COURSE, FIVE STAND, OR TRAP FIELD.

SHOT GUNS AND AMMUNITION:

1. Only shotguns are allowed on club property. The allowable gauges are 12, 16, 20, 28, or 410
2. Shot Shells are to be LOW BRASS GAME OR SPORTING CLAYS LOADS with a shot size NO LARGER than 7.5. You may be asked to show a course attendant your shot gun shells.

SHOT GUN HANDLING AND PROCEDURES:

1. All shotguns must always have the breach open while transporting, walking, or exiting the shooting stations.
2. Guns will remain unloaded until you are in the shooting station with the barrel pointed out and over the front rail. The gun must always be loaded and unloaded in that position. When leaving the station, the gun must be unloaded, and the breach open.
3. There are only two shells allowed in a gun at any time while shooting.
4. In the event of a gun "jamming," the gun must be pointed out and over the rail, and call for assistance if needed. NEVER turn and point a jammed gun behind you at the shooting station.
5. Shotguns must be properly held in the gun racks during transportation.
6. Even if the gun is open, unloaded, and safety locked, it must still be pointed in a safe direction at all times.
7. NEVER point a gun at another person.
8. Keep your finger off the trigger until you are ready to call for a target and shoot.
9. You are not allowed to shoot outside of a station.
10. Only one shooter can shoot at a time at each shooting station.
11. Inexperienced shooters must seek assistance from trained staff and shall volunteer to be under proper guidance.

GENERAL CLUB RULES:

1. Leave all weapons and ammunition in your car or on gun rack until registration is complete.
2. Guests, visitors, and club members are not allowed to carry any weapons other than shotguns onto the club premises at any time. Law enforcement officers, licensed carriers, and staff members are exempt.
3. Observe and follow all signs, rules, and regulations on the club premises.
4. All visitors under the age of 18 must be registered together with and accompanied by an adult while on the club premises. You are responsible for making sure any minor is aware of all rules and follows them.
5. No one under the age of 16 is allowed to operate golf carts.
6. Never consume alcohol or drugs before or while shooting.
7. You may not participate in any shooting activity if you are under the influence of medication.
8. Any damage to golf carts, rental items, or other club property shall be disclosed to staff immediately, and proper action taken to remedy or pay for damage.
9. Do not enter wooded or restricted areas.
10. Do not approach or attempt to repair any target machine. If a target machine breaks down or is not working, please report it to staff or call the office. Phone number is listed at each station.
11. Shooting of any wildlife is against the law and is strictly prohibited.
12. Courteous manners, appropriate clothing, and proper language are required. Clean your area before departing. Barrels are provided for used shotgun shells at each station.
