Research Summaries: Latest Studies in Audiology

Untreated Hearing Loss Increases Hospitalization Risk

Lin et al., 2013 – JAMA Internal Medicine

- Older adults with untreated hearing loss had a 32% higher rate of hospitalizations over 10 years.
- Hearing loss was independently associated with increased burden of disease and medical costs.

Key Insights:

- Hearing loss is a medical condition with systemic consequences not just a hearing aid issue.
- ENTs are uniquely positioned to detect hearing-related health risks early.
- Integrated care models lead to better outcomes and higher patient satisfaction.

Why Hearing Loss Is More Than a Sensory Deficit

For decades, hearing loss has been viewed through a rehabilitative lens — treatable primarily with devices. But growing evidence reveals its broader links to cognition, depression, isolation, and systemic health outcomes. As physicians who specialize in the ear, ENTs must reclaim leadership in hearing care.

- Untreated hearing loss is independently associated with increased dementia risk, fall frequency, and hospitalization rates.
- It is often misidentified or under-addressed during ENT visits when diagnostic bandwidth is limited.
- Referring patients "for a hearing aid" without diagnostic context undermines patient outcomes.

Changing the Narrative in **ENT Clinics**

ENTs can play a pivotal role in reshaping patient and staff expectations:

- Reinforce that hearing care is a medical service — not a retail solution.
- Prioritize diagnostics and brain-based interpretation before treatment.
- Integrate audiology into medical discussions (not just surgical triage).

Clinical Benefits of ENT - Audiology Alignment

- Stronger interdisciplinary communication between physicians and audiologists
- Higher treatment plan adherence from patients who understand their diagnosis
- Greater revenue capture when audiology is embedded into clinical pathways


Rebuilding the Medical Model of Hearing Care
