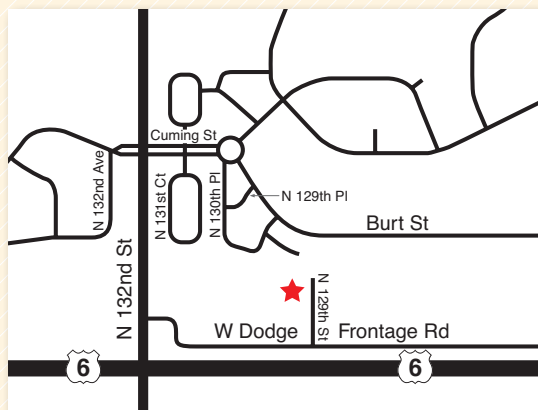
Brenda Ohlrich, MS, CCC-A

impact of hearing loss

The impact of hearing loss goes far beyond that of basic communication. As something we often take for granted, we don't always realize how difficult life can be with impaired hearing. The effects are quite far reaching, though, and can be detrimental to a person's well being.

Social Well Being

Hearing loss can cause a great deal of strain with friends and family members as the ability to have a normal, healthy relationship with them becomes more difficult. It is also increasingly difficult to have long distance contacts through the telephone, thereby limiting a vital means of communication.

Physical Well Being

The physical well being of people with hearing loss can be greatly jeopardized. Hearing loss can interfere with medical diagnosis, treatment and management, which presents a clear danger to the health of that person.

Emotional Well Being

Hearing loss can complicate the ability to live independently and safely, which can make someone feel

like a hindrance to others. Also, work efficiency can be complicated, leading to a feeling of inadequacy in the workplace.

what is hearing loss

Normal hearing depends upon the proper function of literally millions of structures and processes every second. Occasionally, one or more structures within the auditory system fail, resulting in hearing loss and speech understanding challenges.

Approximately 1 out of every 10 people suffers from some degree of hearing loss. This can be caused by a wide variety of things, including: aging, noise exposure, heredity, ear infections, viral infections, head trauma, and certain medical treatments and antibiotics.

As with most other health problems, early detection allows for more effective intervention. In some cases, hearing loss is medically treatable and may be improved without the use of hearing aids. Typically, hearing loss is permanent, but modern hearing aid technology is able to increase the ability and range of hearing in most people.

While there is a charge for hearing tests (some insurance carriers cover this charge), there is not a charge for hearing consultations. We maintain state-of-the-art diagnostic equipment, sound treated rooms, computerized fitting software, and verification tools. We offer real ear measurement, visible speech, video otoscopy, and custom ear protection.
