- 1. Tuition payments are due the FIRST TUESDAY of the month. Monthly tuition charges are:
 - \$185.00 for first child,
 - \$170.00 for each additional child,
 - \$120.00 for active LCBC members.
- 2. The annual Fall/Spring enrollment fee of \$100.00 must be paid at the time of enrollment/re-enrollment. This payment covers both Fall and Spring semesters.
- 3. YOU ARE OBLIGATED TO PAY, EVEN WHEN YOUR CHILD IS ABSENT. PDO reserves the right to adjust tuition as may be required by operational expenses. If your account is not paid in full by the 15th of the month, your child may not attend PDO until the account has been **paid in full**. Late accounts must be paid in full by the close of the month, or your child will be dropped from the PDO program. To re-enroll, you will be required to pay and all past due amounts. If space is not available, your child will be placed on the waiting list.
