

\*Insurance increased \$3,000/Yr and \$1,000 to \$5,000 deductible. Roof is only covered for structural damage.



## Pastor Michael D. Sparby

I also want to thank all of our women's and men's groups, Sunday school teachers, altar guild members, and those serving coffee and lunches before and after services. A sincere thank you to Joyce Gilberts for assisting Pastor with in-home and nursing home visits too. Our congregation is truly blessed.

At the end of the year, a Vision Task Force was created to work with Pastor Michael's transition him to  $\frac{1}{2}$  time. This group will continue meeting with Pastor throughout the year to assess and ensure that our congregational needs are met. As we start 2026, we ask all New Hope members to prayerfully consider serving in various needed roles as Pastor Michael transitions to  $\frac{1}{2}$  time.

Lastly, our congregation will need to make improvements as our facilities continue to age. This past year, our Sand Creek site updated its Wi-Fi and hearing impaired equipment. With ongoing inflation rates, supply costs, insurance, property taxes, it is critical that members continue giving as they're able so our upcoming needs and projected budget can be met. Our congregation has been truly blessed by your generosity. It is greatly appreciated.

During the cold winter months of 2025, the Outreach Committee hosted a *Community Game Day/Night* at both our church sites. Fun was had with many games such as Indoor Scavenger Hunt, Bingo, Trivia, Left Center Right, and not only fun, but knowledge gained with Bible Jeopardy! Of course, treats were served! Watch your calendar as more fun is coming soon!

New membership reception was held in January at Mark Gilbert's home. It was a fun evening getting to know each other with more delicious munchies!

Several congregation members enjoyed a Defibrillator "refresher" course by Lance Loftus (Menomonie Fire Dept. FireMedic). The lifesaving machine applies electric current to the heart to restore a normal heartbeat. It was good to see our unit in action as it directs operation step by step. Thank you Lance for sharing your first aid knowledge! A LifeVac was also demonstrated for use in choking; an easy to use, non-invasive unit. This is located by the first aid kit at Sand Creek. CPR certification class was rescheduled from fall 2025 to January 11, 2026 by instructor, John Farrell, due to an emergency. Lunch was served for attendees.

Continue handing out *Random Act of Kindness* cards, reminding us to continue acts of sharing our faith and church with kindness, love and caring in our community and beyond.

Once or twice monthly visits with holy communion are made to those in a facility or upon request.

*Noisy Offerings* received are greatly appreciated for our monthly missions. Details are found in the financial reports.

## Property/Management Committee

Both sites had a rather quiet year of unexpected property management issues; thank you, Lord!

### Sand Creek Site:

HVAC contract with Gene's Heating & Cooling in Bloomer keep the aging systems operating well. We need to monitor the 8 aging AC units and 29 yr. old boiler furnace. Synergy documented a reduced propane usage in 2025 partially attributed to improved furnace ventilation in 2024.

Reorganized shed easily stores the 50+ New Hope Quilters boxes prior shipment to Lutheran World Relief (LWR) and Global Health facilities in the Twin Cities, MN.

The aging John Deere lawn mower experienced a broken mowing deck this fall. Tractor Central/Menomonie estimated repair to be cost prohibitive for the overall condition of the existing mower. Property/Management Committee recommended to contract local lawn care service in the future vs. purchasing a new estimated \$6,500 lawn tractor. Council approved the recommendation awarded to All Right Lawn Care, LLC/Jerry Loftus going forward. We sincerely thank Mike Olson for his past 4 years of service!

A hired professional cleaned the large interior windows between the narthex and sanctuary, and the offices.

Thank you Lacey Buhr & family for your excellent custodial service!

## Family Education Committee

2024/25—Mother's Day, Sunday school curriculum, Stories of the Bible, each week designated a story with a correlating craft/activity. Approximately 10 kids attended evening Vacation Bible School (VBS), "Bible Beach Club" held Sunday June 8—Thursday, June 12th at Sand Creek Memorial Park. Day 1: Jesus' miraculous catch of fish wasn't just a cool trick; it was a sign of His divine power and call for us to follow Him, proving He is our savior. 2025-26 academic year began in September with new curriculum, Stories of the Bible in picture format. We had a few lessons before Christmas pageant prep. "CHRISTMAS" Pageant was outstanding for kids and congregation alike; symbolizing each letter with song shared with the congregation!


## Men's Group

**We can always use more members; all ages welcome!** Wishing you all a happy 2026 New Year.





# Presiding Bishop Elizabeth Eaton

## *Ends Her Season Serving the ELCA*

### ***Ending at the Beginning* Farewell 9/19/25**

I started my ministry as presiding bishop with these four emphases: We are church. We are Lutheran. We are church together. We are church for the sake of the world. I will end as I began.

**We are church.** There is no other institution on earth whose reason for being is the proclamation of the gospel. “It is also taught that at all times there must be and remain one holy, Christian church. It is the assembly of all believers among whom the gospel is purely preached and the holy sacraments are administered according to the gospel” (Augsburg Confession, Article VII). That’s it. The works we do in service to the world are important, but they are not the essence of the church. The ELCA does not exist in order to work for justice. Rather, because we are nourished by word and sacraments, the ELCA is free and empowered to do so.

The church is also marvelously intricate and interconnected. “We, who are many, are one body in Christ, and individually we are members one of another” (Romans 12:5). There is no such thing as a solitary Christian. God’s love for us through Christ and poured into our hearts by the Spirit is for each of us. But each of us is just one member of the body of Christ. We understand the church in the same way. “This church shall seek to function as people of God through congregations, synods, and the churchwide organization, all of which shall be interdependent. Each part, while fully the church, recognizes that it is not the whole church and therefore lives in an interdependent relationship with the others”. (ELCA “Constitutions, Bylaws and Continuing Resolutions” 8.11.)

**We are Lutheran.** The average Lutheran in the Lutheran World Federation (LWF) is a woman in Tanzania. There are more Lutherans in Ethiopia, Indonesia and Madagascar than in the ELCA. The LWF has 150 member churches in 99 countries. What binds us together? Certainly not one culture or cuisine. Rather, it is the clear witness of the gospel that sets us free. “It is taught that we cannot obtain forgiveness of sin and righteousness before God through our merit, work, or satisfactions, but that we receive forgiveness of sin and become righteous before God out of grace for Christ’s sake through faith …” (Augsburg Confession, Article IV).

This is revolutionary. The standards of the world by which we are measured, or we measure others, are a figment. We don’t claim perfection for the church. We’re not there. But as Martin Luther said, “This life therefore is not righteousness but growth in righteousness, not health but healing, not being but becoming, not rest but exercise. We are not yet what we shall be, but we are growing toward it, the process is not yet finished, but it is going on, this is not the end, but it is the road. All does not yet gleam in glory, but all is being purified” (“Defense and Explanation of All the Articles”). We know there is law and gospel, that we are saint and sinner, that we are bound and free, and we entrust that all to God.

**We are church together.** Paul wrote that we do not live to ourselves. We live in a time when fear is used to separate us. This is the tool of every authoritarian regime. The church is different. The Spirit calls, gathers and keeps the whole church on earth. We belong to God, we belong to each other, and we belong to the world.

**We are church for the sake of the world.** We are not only freed from sin, we are freed for service to the neighbor. Here is where the essence of the church—the proclamation of the gospel—gives power and shape to the work we do in Jesus’ name. We are church for the sake of the world not out of obligation or for reward but out of love.

So there it is, dear church, my farewell address. We each have this ministry for a season. My season as presiding bishop has ended. Bishop-elect Yehiel Curry’s season is about to begin. Pray for him, his family and the churchwide staff. But be assured that the season for the ELCA is not over. God hasn’t finished with this church yet.



## Welcome, Yehiel Curry

### New Presiding Bishop of the ELCA

Rev. Yehiel Curry was elected presiding bishop of the ELCA at the July 20th Church-wide Assembly in Phoenix, AZ. His role began Oct. 1st. He was installed Oct. 4th at Central Lutheran Church in Minneapolis.

Recently, he served as bishop of the ELCA Metropolitan Chicago Synod, leading a synod staff and 160 congregations; providing pastoral care, preaching, teaching, administering sacraments, and overseeing ordinations/installations. He was elected synod bishop in 2019 and reelected spring 2025. Curry chaired the ELCA Conference of Bishops, fostering ecumenical relationships and theological engagement across the Lutheran communion.

Previously, Curry served as mission developer (2007–12) and pastor (2013–19) of Shekinah Chapel Lutheran Church in Riverdale, IL. He earned a Bachelor of Arts from Lewis University in Romeoville, IL, and a Master of Divinity from Chicago Lutheran School of Theology. He and his wife, LaShonda, are proud parents of three daughters.

### Bishop of Northwest Synod of WI

To the amazing disciples of the Northwest,

As I reflect on this past year, one of the most significant moments came at the fall Conference of Bishops, which was held immediately following the installation of our ELCA Presiding Bishop, Yehiel Curry. In his first address to the conference, he talked about a one word focus for his first year, *connection*. As soon as he said it, I was already engaged, especially since that has been one of my goals in my first year!



As I tour this great synod of ours, I’ve already been to over 50 churches representing over 60 congregations. It helps a lot when I can experience a worship opportunity where multiple churches come together, as was the case in Menomonie and Eau Claire! Needless to say, I enjoy learning about the history and more importantly, the people that each congregation has to offer. So distinctive, yet at the same time, we are all still a part of the same team, connected by our common faith and common mission to love our neighbors.

Speaking of our neighbors, I’ve made it a priority to lift up the important ministry of “Neighbor to Neighbor”, staffed by Deacon Lidixe Montoya and supported by a newly appointed board at last year’s synod assembly. It was at that same assembly where we adopted a resolution to raise \$175,000 over three years to support this ministry that is already making great strides in supporting the Latino community throughout our synod. I would invite you personally to contribute toward this goal and/or increase what your church contributes to this ministry on an ongoing basis. “Neighbor to Neighbor” is a ministry that is so critical right now as so many of our Latino friends live in constant fear of deportation, which can inhibit their ability to even worship in public! We have a tremendous opportunity to show them they are loved and valued, so let’s come together for this important purpose.

Another highlight of 2025 was attending my first ever Church-wide Assembly in Phoenix, AZ. In addition to electing the first black Church-wide Secretary, CeeCee Mills and Presiding Bishop, Yehiel Curry, we also passed yet another social statement, *Faith and Civic Life*. The rostered leaders of the synod will be spending some time digesting it at our upcoming Winter Theological Event in hopes to equip them to lead a study in your church. I would strongly encourage you to participate in this study as it addresses many of our current realities, including the issue of Christian Nationalism. This is a strong movement that is sweeping the country, but remains largely in conflict with our Lutheran beliefs. *Faith and Civic Life* conversations can help us all remain rooted in our faith and help us understand how to be engaged in life beyond worship.

To close, I’d like to thank you for your relationship to the synod. We truly can do more together, staying *connected*. We cannot reach out to the many different groups throughout the synod without your generosity. May we continue to innovate in 2026 as we work collaboratively together and share the love of God throughout our communities!
