**Minutes of the Annual Meeting of the Congregation of Lutheran Church of the Redeemer**  
**February 9, 2025**  
**Hybrid Meeting, in Person and via Zoom**

**Call to Order:**

President, Ellen Kennedy called the meeting to order at 12:08 PM.

Pastor Kessinger opened with prayer.

President Kennedy offered information regarding the distribution of materials that were organized in advance of the meeting. She then gave an overview of the areas of focus for the annual Meeting.

**Consent Agenda and Approval of Minutes of Previous Annual Meeting:**

The agenda-as-a-whole, including the Meeting Agenda, Pastor's Report, Council President Report, Ministry Reports, and the minutes from the 2024 Annual Meeting were published in the Annual Report. President Ellen Kennedy asked for a motion to approve the agenda-as-a-whole with a correction indicating that Mark Thronson is nominated for a first 3-year-team (not second 3-year-term as originally published) on the Endowment Committee. The motion was made from the floor, it was seconded from the floor, and the agenda-as-a-whole was accepted unanimously.

**Pastor Report:**

Pastor Kessinger opened with a reading from Philippians and shared the journey of her decision toward retirement on July 1, 2025. She briefly outlined the scope of Redeemer's upcoming transition, to include the process for identifying an interim pastor in the short term and organizing the call process for a senior pastor in the long term. Redeemer will be in consultation with Pastor Sarah Garrett Krey, Assistant to the Bishop.

Music Director Matt Osifchin delivered farewell remarks and announced plans for a musical sendoff for Pastor Kessinger to take place in June.

A Congregant expressed appreciation from the floor for the efforts PSK made to ensure a smooth transition since the announcement earlier this year of her retirement

**Treasurer's Report:**

Treasurer Ed Regan briefed the Congregation on the Financial Report from 2024. He expressed appreciation for Financial Coordinator Sara Nail for her guidance and expertise in preparing financial reports for this meeting and throughout the year. There were no questions or discussion regarding the financial report.

**Ministry Highlights - Social Justice and Equity Book Club and Sacred Ground:**

Mary Eckberg and Clare Dutrow introduced the Congregation to the activities and purpose of the Social Justice and Equity Book Club. The group meets on Monday evenings via zoom to discuss a variety of books on the topic of racial equity. Books are announced in advance in the announcements and copies are available in the Crossroads for anyone to borrow.

Mary Eckberg presented the activities and purpose of Sacred Ground to the Congregation. Sacred Ground is a series of sessions, developed by the Episcopal Church, to study and discuss race and faith. Sacred Ground participants meet monthly via zoom, and all are invited to attend.

**Ministry Highlights – Stewardship:**

Matthew Kratz referred the Congregation to the Stewardship report and encouraged congregants to participate and share their time, abilities and resources to the church.

### **Action Item - Recommendations for Council from the Nominating Committee:**

Ellen Kennedy read the names of candidates recommended for Council from the Nominating Committee as listed in the agenda:

A motion was made from the floor to accept the nominees. The motion was seconded on the floor. The slate of candidates was approved unanimously.

### **Action Item - Recommendations for Endowment Committee from Nominating Committee:**

Ellen Kennedy read the names of candidates recommended for the Endowment Committee:

- Stephanie Hunter (First 3-year term)
- Mark Thronson (First 3-year term)

A motion was made from the floor by Karen Miller to accept the nominees. The motion was seconded from the floor. The slate was approved unanimously.

### **Action Item - Election of Voting Members to the 2024 Synod Assembly:**

Ellen Kennedy read the names of recommended voting members to the 2024 Synod Assembly:

Ellen Kennedy made the motion to accept the recommendations. The motion was seconded from the floor. The slate was approved unanimously.

### **Action Item - Presentation of Proposed 2025 Budget:**

Rob Wenk presented the proposed 2025 Budget. He provided context for the increase in the **Building and Grounds** line item, the increase in the **Administration** line-item, and the new line of **Debt Payment/Placeholder**.

Nate Paukovits made the motion to approve the proposed Budget. The Motion was seconded from the floor.

A congregant asked for and received confirmation that Redeemer is not subject to any increase in property taxes on building and grounds.

A congregant asked for and received clarification of the proposed amount of \$24,000 as Debt Payment/Placeholder.

The Congregation voted to adopt the proposed 2025 Budget as presented in the agenda.

### **Discussion Item - Beyond Measure Update:**

Laura Magnuson, co-chair of the Redeemer Renaissance board, and family expressed their support for the playground and outdoor work as part of the Capital Campaign and Building Project.

Mary O'Brien summarized the fundraising activities of the Beyond Measure campaign during the year. Funds have been collected from previously pledged amounts, activities such as the donut sale and ice cream social, and contributions made outside of pledges.

Rob Wenk guided the congregation through activities of the Building Project:

- Bids have been collected and walkthroughs have been scheduled with potential contractors.
- Financing options with Chain Bridge Bank (who financed previous campaigns), and the ELCA investment funds are under review.
- Plans have been submitted to Fairfax County to obtain the necessary permits.
- Interior work is anticipated to commence in late summer, and exterior work in the fall.

#### **Action Item - Approval of Mortgage:**

The following motion was made previously by Council and is subject to approval by the congregation this afternoon:

“Based on the current total estimated project costs of \$3.2 million, and based on the current pledge and giving totals of \$1.6 million, the congregation authorizes council and its leadership to enter into a mortgage for not more than \$1.6 million to be amortized over a 25-year term based on best loan rates and terms available at the time.”

The motion was seconded by Max Miller.

Comments and discussion from the floor focused on the points below:

- A congregant mentioned the age of the building and interior spaces and the need for capital improvements to address functionality issues.
- A congregant mentioned the need to plan for alternate spaces or develop contingency plans for ongoing activities such as Faith Formation classes, day-to-day business operations, and facilities usage by outside groups during construction.
- A congregant expressed appreciation for the work and effort Rob Wenk and his team have made over the years in putting this project to fruition.
- A congregant sought and received historical context for collecting on pledged contributions, as well as the amount of cash on hand at this time.
- Three congregants asked about the feasibility of reducing the mortgage amount by drawing from other sources, such as borrowing from Redeemer’s reserves, securing a personal loan from an individual donor, or drawing from a line of credit.
- A congregant sought and received background on the increased costs associated with the project and contingency plans for unanticipated increases along the way.

The congregation ended discussion by a 2/3 voice-vote and paper ballots were distributed to vote on the approval of a mortgage.

Votes were tabulated and the Congregation voted to approve the motion as follows:

- Zoom: Unanimous in favor.
- In Person In Favor: 54
- In Person Opposed: 2
- In Person Abstaining: 3

#### **Discussion Item - Souper Bowl Results:**

Souper Bowl contributions from the three services were added up. The Steelers topped both the Eagles and the Chiefs and walked away with the win. Pittsburgh Steelers \$264. Kansas City Chiefs: \$247. Philadelphia Eagles \$110. A total of \$621 was raised.

#### **Adjournment:**

Pastor Kessinger closed with prayer and asked that we keep all members who are in hospital or who are dealing with financial uncertainty in our prayers.

Max Miller made a motion from the floor to adjourn the meeting. Laura Duval seconded from the floor. The congregation unanimously adjourned the meeting at 1:31 PM.

## 2025 Report by Pastor Sharon Core



Siblings in Christ,

Grace and peace to you. As you reflect on 2025, I add my thoughts to your annual report.

Last year, you said goodbye to your pastor of 13 ½ years and hello to me. My hope is in the 6 months we have now spent together, you have a sense of the possibilities of this interim time and the necessity for it.

I am grateful for the ways you have welcomed me and have, for the most part, patiently answered my questions. Part of my responsibility as your interim is to ask a lot of questions!--questions based on what I see, why things are done the way they are and what practices can be different.

In this in-between time, I am intentionally doing some things differently. If I can offer ways of being, serving, studying, worshiping that are a bit different from what you are “used to”, it will give your next pastor the freedom to shape their ministry without hearing “this is the way our last pastor did it”.

I want to raise for you three areas that from my perspective would be good for you to address/chew on/think about before your next pastor arrives.

**1. Faith Formation, Adult Education and Worship:** Redeemer has a strong Faith Formation program and you are blessed with teachers who care about the children and youth. The teachers are passionate in their teaching and are serious about being trusted adults for the younger members of the church. There are nineteen 7th and 8th graders in confirmation! The Bible and Bagels class is well attended by High School students. Table Talk is well attended and is the only Adult Education class on Sunday morning.

The Sunday morning worship schedule is full—8:30, 9:45 and 11:00. We have a *Children’s Message* at all three worship services and for most of the time have children there for that part of the service. However, we do not have the population of children and youth in worship as are present in Faith Formation. My wonderment is when do the children and youth experience worship? When those in confirmation make the decision to join the church, many of them will not have regular worship experience. Given the Sunday schedule, not many families worship together; parents usually attend the 9:45 service and children/youth are in Faith Formation.

Most people who attend worship are adults. Their experience of worship is strong and I wonder about their Christian education. If adults don’t attend Table Talk (during the 9:45 service), what are other learning/exploration opportunities?

I would suggest an overarching conversation that takes into account children, youth, adults, worship and education. It may be that something needs to change.

**2. Where do things live:** On more than one occasion, I have had someone say to me, “Has anyone told you about \_\_\_\_\_?” My response usually has been “no” followed by “and where in the organization structure does this live?” “Well, it’s really just something that \_\_\_\_\_ does.” I believe a worthwhile endeavor would be conversation about the myriad of opportunities for service, fellowship and involvement. How does the congregation claim these? And which group/committee is tasked with

“making them happen”? For a congregation the size of Redeemer, a clear understanding of who is responsible for what, how committees and groups work together and how the congregation and pastor work together will serve you well in the long run.

**3. Life-long stewardship:** I was surprised when I arrived there were no plans for a stewardship focus in the fall. My own tradition, while not perfect and always has room for improvement, has a fall focus on the gifts/pledges people in the congregation make. Part of our identity as disciples is that of steward—the way we share our gifts—and yes, that includes “time and talent”—it also includes our money. Conversation and reflection around our understanding of and use of money are topics worthy of year-long attention.

I am grateful to be with you at this time. I trust we will continue to discover areas to explore as you ready yourselves for your next pastor.

By December, we were moving the staff over to the new (and beautiful) classroom wing so that the remodel work on the office wing could begin. If you haven't taken a look, please do so!

Pastor Core has been a steady guiding presence as we execute the process of transition to prepare for calling a new pastor. I am grateful for her leadership.

## Building and Grounds Committee Report

The Building & Grounds group has been involved with a variety of projects throughout the year:

- Maintenance of the church grounds was completed by the committee volunteers through weeding, mulching, pruning, trimming, and watering resulting in significant operational cost savings to the church.
- Replaced a steel door that had started to rust through in Music Suite A.
- Installed new sound absorbing panels in the Gym and Fellowship Hall.
- Replaced a roof top HVAC unit that had failed with new model that is more efficient.
- Developed a new cabling plan for voice and data to support the new and temporary offices.
- Replaced a section of a casement window in a Preschool classroom that had rotten wood.
- Installed a wireless upgrade of the alarm system to reduce old telephone line requirements.
- Expanded the fire alarm panel to handle the construction and replaced a problematic sensor.
- Began expanding and upgrading security cameras to cover more areas with better resolution.
- Sold, donated or stored excess equipment and items from the old classrooms and offices.

### Building & Grounds Master Plan Construction

- Started renovation construction of the classroom wing as scheduled on August 19.
- Turnover from construction of the classroom wing was completed on December 2.
- Staff members were moved from their offices into temporary spaces in the renovated areas.
- Started renovation construction of the office wing as scheduled on December 15.
- If everything stays on schedule, the office wing renovation should be completed mid-April.
- Received county approval on the site plan for the columbarium and playground renovation.
- Waiting for a county building permit for revised construction documents for outdoor areas.
- We sent out RFPs (Request for Proposals) to several area general contractors, including the firm that is currently doing our interior building renovations. Unfortunately, the bids have come back much higher than we were expecting. The construction budget for the outdoor work was based on two rounds of estimates done during the design phase from an independent estimator. However, additional county requirements for storm water management and tree protections and annual rising costs have led to this situation. We are currently working with our architects, engineers and the general contractors to determine how we can reduce these costs and plan for a path forward.

Special thanks to Pete Poulos, Steve Koenig, Joyce Clarke, Susan Posey, Alice Lockhard and Tyler Posey who have volunteered many hours to help care for the grounds and the Memorial Garden. We are always looking for help with the grounds and with minor building repairs. ## Endowment Committee Report

### *“Charitable Giving to Support Mission Outreach”*

Redeemer’s Endowment Fund (Fund) was established in 1995 by the congregation to expand our mission outreach. Gifts to the Fund can be in any amount, at any time, and remain permanently invested. Only earnings are dispersed to charitable organizations with at least 50 percent of the annual amount used within our Metro Area.

The Endowment Committee has five members elected to 3-year terms. It manages the Fund and recommends grants subject to Church Council approval. The current members are Stephanie Hunter '28\* (Chair), Dr. Gene Morrow '27\* (Financial Secretary & Council Liaison), Mary O'Brien '26\* (Recording Secretary), David Broderdorf '27\*, and Mark Thronson '28\*.

In 2025, \$18,000 in grants addressed immigration, food security, health, and foster care/youth, with \$12,000 (67%) used locally. Grant recipients are announced in Tidings or Temple Talks.

## Faith Formation Report

I would like to start by saying thank you to all our incredible teachers. We have been blessed with an amazing set of mentors that have volunteered their time and energy, helping to create a fun, nurturing and educational environment for our youth. Thank you!

In May of 2025 we closed out a successful year of classes and paused for the summer. Our gratitude goes to Shelley Brennan who ended her years long dedication to the program including teaching Confirmation in the 2024-25 school year.

In the 2024-2025 school year, we had 51 students registered for Pre-K to 6th Grade classes. We also had 18 students registered for Confirmation class and 16 registered for our High School class. Attendance was strong across all classes last school year!

Grace Howie has taken over the logistical aspects of the Faith Formation and Confirmation programs for 2025 - 2026. She is assisted by Jackie Budde who serves as our scheduling coordinator for teachers and volunteers. Faith Formation for youth, in all its forms, re-started for a new school year in September 2025 including six classes led by a wonderful team of new and returning mentors:

- Pre-K – K: Sara Egeland and Tricia Engle
- 1st – 2nd Grade: Joy Hughes and Mark & Melanie Heuer
- 3rd – 4th Grade: Ellie and Katherine McGuire
- 5th – 6th Grade: Greg Adams
- Confirmation: Josh Magnuson, Paula Green, and Douglas Johnson
- High School: Kim Wenk and Christian Richter

We have a group of 10 substitutes that we are thankful for, as they step in when needed. We are also grateful to all the parents who have volunteered their time this year.

Registration for the 2025-2026 school year was lower for Pre-K to 6th Grade with 36 students registered. However, our Confirmation class grew to 20 students registered. High School has 18 students registered. Attendance continues to be strong this school year.

The Pre-K – K class focuses on a different Bible story or core message each week. We are using the Feasting on the Word curriculum for the 1st to 6th grade classes, which follows the lessons that are heard in worship each week. Our confirmands have been focusing on the Bible this year. And our high schoolers enjoy bagels each week along with open discussions on how the Bible applies to their lives. Our younger students are again starting each class with a musical opening, led by Waka Osifchin. Students have been learning both classic and contemporary Christian songs and we are very blessed to have Waka sharing her beautiful voice and time with them!

## Redeemer Renaissance Report

You are welcome to share in the joy! As in past years, we reflect on the life Redeemer Renaissance Preschool and After-School (RR) ministry brings to the halls and beautiful grounds of RLC as we endeavor to build community centered around quality education and Christian values. As we grow our learning community to include multi-generational interactions the **INSPIRE** volunteer program affords meaningful opportunities for church members, middle-schoolers, high-schoolers, and community members to join us in growing by sharing their time and talents. Our children thrive and feel safe in inclusive community environments rich with learning opportunities and the caring personalities of those who interact with them in life!

Each year that passes brings blessings to the Redeemer Renaissance ministry, and we are thankful for the support shown throughout the year by our Redeemer families, Pastor Core, Pastor Kessinger, Katrina McNair, our Preschool Director, the After-School (AS) and Preschool (PS) Board members, Grace Howie, and most importantly, our talented staff and dedicated volunteers. Our experienced staff, consisting of thirty regular staff members and eighteen substitute and seasonal staff members, bring their professional strengths forward as they support our families, students, and teachers that come together to fill the classrooms each day. We are thankful for Fairfax County resource teachers and other professionals such as speech and behavior specialists who provide targeted support for eligible students. We are grateful as we come together to fill each year with memories, reminding us of the importance of our mission to provide early childhood education and enrichment opportunities for children ages 2 to 12.

Highlights for 2025 include:

- RLC Community Engagement Events: Sharing God's Love – Monthly service projects, Time with Pastor, RLC committee and McLean community partnerships.
- RRPA Family Engagement Events: Building Bridges and Community – Connecting with families by providing educational and social opportunities onsite and in the McLean community.
- RRPA Staff Professional Development and Training – The Creative Curriculum (play-based), vetted by the VA Department of Education and promotes evidence-based, child-centered learning tailored for students in our care. Classrooms offer space for Learning Lab STEAM projects. Science, technology, engineering, art, and math combine for infinite exploration and discovery. Teachers and staff facilitate nature components in the Outdoor Classroom. The Log Circle, Butterfly Garden, Natural Play Area, and Play Structures invite magical adventures and learning.
- Enrollment for RRPA is increasing, with tours scheduled weekly. Families most often hear about our programs through others in the community.

After-School and Preschool formal year-round program offerings include:

- Good Beginnings for Toddlers and Caregivers - Offered bi-weekly throughout the school year (9:30 AM – 10:30 AM).
- 2.5 – 5-year-old Classes - Offered as part-time, full-time, morning only (8:30 AM – 12 PM), and all-day options (8:30 AM – 3 PM).
- Child's Afternoon Out – 2's discovered with invitations to create art and play (12 PM – 3 PM & 3-5 PM).
- Learning Lab – 3's and 4's explored with STEAM activities and nature projects. (12 PM- 3 PM & 3-5 PM)
- K-6th After-School - Daily programming included STEAM, sports, tutoring, music lessons, enrichment classes, and community building projects. Transportation provided from Churchill Road, Franklin Sherman, Haycock, and Kent Gardens Elementary Schools (2:30PM – 6:15 PM).

- K-6th Teacher Workday Special Camps – Children from local elementary schools attended these 7 days of camps to engage in Reverse Engineering, 3D Art, Laser Tag, Lego Rally, workshops, and performances by professionals and more. (8 AM – 6:15 PM).
- Preschool and K-6th Camps – Over 200 children from local schools joined in summer and spring camp fun, making friends through activities such as games, art, science, workshops, water day, movie day, silly Olympics, Laser Tag, animals, and performances. Every day of camp is unique! (8:30 AM – 6:00 PM).

The Redeemer Renaissance Advisory Board met throughout the year to provide feedback regarding programming, planning, aligning language and dates in the Board Charter with the RLC Constitution, and budget suggestions. The board meets quarterly and includes RLC members, parent representatives, the Pastor, a RLC Council liaison, the Preschool Director, and the Executive Director.

Join us to **INSPIRE** in 2026! A significant part of our success in engaging with church and local families is due to our placing value on our community, observed through outreach and active involvement. We are proud to say that children who have attended our programs often partner with us for service-learning opportunities, come to work with us, and lead children in our programs!

- Three prior program attendees, now in H.S. and M.S. volunteer weekly as assistants to the staff. Volunteers are **INSPIRED**, and their experiences serve them and our community well.
- Members of our staff, including teachers, teaching assistants, substitutes, music teachers, and tutors are often former parents of children who attended the program, or knew someone who worked with or attended the program.
- Three of our previous students are currently serving as a teacher in the program, and three more are serving as camp staff.

Parents, church members, friends, family, and community members honor the children and our ministries by volunteering their time and resources. Heartfelt thanks to all!

Recipients included: Partner for Surgery (81 quilts, 24 flannel baby blankets, 200 bags with bears); Project Linus (47 quilts and 16 fleece blankets with crocheted edges by the Prayer Shawl group; Pastor Kessinger (a quilt as a retirement gift); Tom Williams, US Army vet, (a patriotic flag quilt during a recent illness), Grace Howie (a quilt as a wedding gift) and Redeemer Renaissance (20 scarves for their scarf drive).

At Pastor Kessinger's retirement party the Quilters provided a service project to design fabric squares using fabric markers for our quilts. In total five quilts were made using the squares.

The group meets on the first and third Wednesday of each month from 9 am to 11:30 am. We welcome fabric/sewing donations, monetary donations (annotate Quilting on the check), and members to design, cut, assemble, and sew. No experience necessary!

### **Little Food Pantry**

Redeemer's Little Food Pantry provides food to our neighbors in need and serves numerous people every day. The Pantry gives people access to food 24/7 without questions, qualifications or judgements. Built by Redeemer's Boy Scouts, the Pantry is located between the parking lot and the sidewalk on Westmoreland Street. All are invited to place canned food items in the pantry and/or donate items in the bin in the Crossroads.

## **ELCA - God's Work, Our Hands (Day of Service)**

On September 7th, a group of Redeemer adults and youth went to Sunrise Assisted Living of McLean for the ELCA "God's Work. Our Hands" day of service. The group hosted a Bingo Game Party for the residents, complete with snacks and prizes.

The Social Justice & Equity Book Club has had another very productive year reading a total of 8 Books! We are a ministry trying to educate ourselves and others about social justice and equity by having open and honest discussions about the books we read together. Our group consists of about a dozen members. We read about 50-70 pages/week and meet Monday nights 7:30-8:30 pm via Zoom. We purchased a total of 8 books for \$91 and many others were donated by our group to put on our lending cart, making them available to the congregation to help others learn about justice and equity. This year we sponsored a "Stumbling Stone" to be placed near the Arlington Central Library in honor of an enslaved person who lived at the plantation where the Central Library is now located; there will be an unveiling ceremony Spring 2026. ## **Spiritual Nurture Committee Report**

Spiritual nurture is a primary focus in the Redeemer community. We support various activities throughout the year that underpin faith and prayer-life growth. Many thanks to Diane Miller and Megan Kratz for leading this ministry in 2025. Highlights are provided below:

- Lenten retreat - On the Saturday before Lent, about 18 people gathered to prepare for the Lenten season. We had thoughtful prayer and conversation, enjoyed fellowship over lunch, and ended our day with prayer and communion.
- Lenten dinners - we continued our tradition of Holden Evening Prayer on Wednesdays during Lent, preceded by a light meal and fellowship. Reflections were offered by several Redeemer members during service, each providing personal and thoughtful themes to be recalled throughout the week. Thanks to Kim Wenk for organizing the dinner preparations.
- Thursday Bible study - thanks to Doug Scheffler for leading the Thursday morning Bible Study. In 2025, we completed our study of the Holy Spirit in November. In December we started a 4-week session on Handel's "Messiah", with a focus on the texts.
- Women's Prayer/Faith Group - this well-attended class has studied various topics this year including women in the Bible and a series on braving change. In December, Pastor Sharon led the group in an Advent study. The group continues to meet Tuesdays at 9:30am, in person and via zoom. Thanks to Mary Eckberg and Kim Wenk for keeping this group alive.
- Advent Dinner and Services - Something new! On 12/3 and 12/10 we held a dinner co-sponsored with the preschool and after-school followed by an Advent Service. Dinners were attended by over 50 parents and children from the preschool and after-school each week. It was a nice way to reach out to our Redeemer Renaissance families.
- Quarterly Days of Prayer were held where members and friends submitted prayer petitions/signed up to pray for specific topics in half hour increments such that the entire day was full of prayer. Thanks to Judy Kuhagen for spearheading that effort.

## **Stewardship Ministry Team Report**

Stewardship is how we carry out our congregation's mission "to share Christ's love with the greatest number of people." Each year we strive to expand how we carry out that mission.

The Stewardship Ministry Team in its quarterly letters emphasized all three aspects of stewardship during the year: time, talents, and financial contributions. Sharing those aspects is common in any community/organization to which we belong. Stewardship within a faith community, however, is a spiritual discipline requiring prayerful consideration.

**Time and talents.** Ministries both within Redeemer and in the local community relied on volunteers of all ages from the Redeemer family. Some of those volunteer opportunities required a regular commitment of time and talents; others were for less frequent or one-time-only situations.

- The volunteer directory, "What's Happening at Redeemer" covering all the volunteer opportunities, was updated twice during the year to give current information about coordinators and their contact information. Copies are available in Crossroads; it and a version for youth are posted on the website home page.
- Emphasis on sharing time and talents was the focus on the first Sunday in November. Representatives of various areas gave Temple Talks at all three services and others were available for discussion in Crossroads between and after services.

**Financial contributions.** Redeemer members and friends gave of their financial resources to help support the obligations of the budget passed in February at the congregation's annual meeting. This ministry team encouraged, via announcements and mailings to members, responding to the need for additional financial contributions to offset the deficit near the end of 2025.

- Members and friends also gave financial contributions and the desired items for various collections by the Social Outreach Ministry for several nonprofit organizations serving those in need in both the local community and elsewhere.

As a ministry team, we challenge all of us in 2026

- to find one more way to share our time and talents to support Pastor Sharon Core, the staff, and ministry team leaders as they plan and direct the overall ministry of Redeemer in this time of transition; and
- to contribute the funds needed to support the congregation's 2026 budget and to grow our response to specific calls for assistance for local, national, and international organizations.

## TableTalk Report

**TableTalk** is a small-group ministry at Redeemer in which participants explore questions of faith, build relationships, and deepen commitments to discipleship. As we gather around the table for Holy Communion as one body in Christ, we also gather around the table as one people for study, talk, and fellowship. We believe it is important for those who are part of the Body of Christ to have a forum for the in-depth study of Christianity and to be able to use those studies as a way of connecting Christian faith with a post-Christian, primarily secular world. As

Christians have done throughout the history of the church, and in accord with our Lutheran heritage, we believe that one of the best places for seeking understanding of the Christian faith is communal discussion with our brothers and sisters in Christ. Accordingly, we meet every week throughout the year for study, talk, and fellowship.

**The Church in the Secular World: Science, Culture, and Religion.** During the first half of 2025 we continued our series on the place of the church in the secular world, focusing primarily on the interaction between Christian faith and scientific culture. Our approach has been historical and topical, with discussions on the evolving nature of scientific understanding from antiquity through the scientific revolution, and then on to the debates surrounding contemporary topics such as modern physics and evolution. We will resume our series on Science and Religion in January 2026.

**Lutheran and Reformed Theology.** During the second half of 2025, we started a new limited series on Lutheran and Reformed theology, given that our interim pastor is a Presbyterian and part of the Reformed tradition. We studied the similarities and dissimilarities between the traditions, such as how the traditions use the concepts of Law and Gospel, how they view the sacraments, and how they approach issues such as predestination. We also reviewed how the Words of Institution in the Sacrament of Holy Communion differ in Lutheran and Reformed usage and the agreements between the ELCA and Reformed churches for the sharing of ministry.

### **Gathering as a Hybrid Ministry**

TableTalk is a **fully-hybrid ministry** of the church, meeting in-person and via Zoom on Sundays from 9:45 to 10:45 am. We offer a simultaneous live-stream to off-site attendees so that on each Sunday morning we have a mix of in-person and Zoom participants.
