Minutes of the Annual Meeting of the Congregation of Lutheran Church of the Redeemer

February 22, 2026

Hybrid Meeting, in Person and via Zoom

Call to Order:

President Karen Miller called the meeting to order at 12:05 PM.

Interim Pastor Core opened with prayer.

President Karen Miller offered information regarding the distribution of materials that were organized in advance of the meeting. She then gave an overview of the areas of focus for the annual Meeting.

Consent Agenda and Approval of Minutes of Previous Annual Meeting:

The agenda-as-a-whole, including the Meeting Agenda, Pastor's Report, Council President Report, Ministry Reports, and the minutes from the 2025 Annual Meeting were published in the Annual Report. President Karen Miller asked for a motion to approve the agenda-as-a-whole, with the addition of an update from Redeemer's Music Director as an agenda item. The motion was made from the floor by Jane Skotzko, it was seconded from the floor by Katherine McGuire, and the agenda-as-a-whole with the additional agenda item was accepted unanimously.

Update from Music Director Matt Osifchin:

Referring to his section of the Annual Report, Music Director Matt Osifchin emphasized the June celebratory tribute to the ministry of Pastor Sandy Kessinger and the Christmas Eve premier of a new composition for full choir, percussion, and brass quintet, which had been commissioned in honor of a choir member who had passed away on Christmas Day 2024. Matt invited individuals to consider contributing their time and musical talents to Redeemer's music program. Matt offered his thanks to the congregation and Pastor Core for their support, and Karen Miller expressed her gratitude for Matt's commitment to Redeemer's musical life.

Pastor's Reflection:

Pastor Sharon Core offered a reading from Ephesians, identified as the "prayer for the reader" for its focus on spiritual wisdom, empowerment, and comprehension of God's love. Pastor Core invited all of us to consider that God is at work in each one of us as we engage in conversations and make decisions about Redeemer.

Transition Team Update:

Samantha Brainard introduced the members of the Transition Team to the Congregation and updated the congregation of their progress in preparing for the call of a new Pastor. She reported that the Transition Team gathers on Sundays and has been carefully reviewing the 120 responses received so far to the survey. After providing a brief summary of preliminary findings, Samantha outlined next steps as follows:

- Small group and one-to-one interviews will be held from March through April to further delve into patterns gleaned from the survey.
- A Call Committee will be created in May
- The Transition Team will make their final report available to the congregation and the Call Committee at the end of May.
- The Call Committee will present the Mission Site Profile to the synod in June.

Sam invited the congregation to bring questions or information to the Transition Team Committee and encouraged participation in the small group discussions.

In response to a question from congregant Charlie Brown, Sam confirmed that upcoming small group discussions would be publicized in Tuesday emails and service announcements.

In response to a question from congregant John Teitman, Sam shared that as of the date of the annual meeting, 38% of members who attend services responded to the survey.

Karen Miller acknowledged the time commitment and the enthusiasm that each member of the Transition Team brings to their work.

Treasurer's Report:

Treasurer Steve Bott briefed the congregation on the 2025 Financial Report and reviewed the Summary of 2025 Operating Fund Activity, the Working Capital Balance Sheet, the 2025 Total Receipts, and the Year End Statement of Plan Assets.

Steve noted that while 2025 ended in a \$10,000 surplus, this was due to a decrease in expenses. Contributions were consistently below expenses starting in quarter 2, all of quarter 3, and through November in quarter 4. He noted that 27% of the total income for the year was raised in December.

Steve thanked the Finance Committee and Sarah Nail for their collective efforts in preparing the report and for their stewardship of Redeemer's resources.

There were no questions from the floor. Karen thanked Steve for his efforts during the year.

Ministry Highlights - Faith Formation and Youth Ministry:

Grace Howie summarized the Faith Formation and Youth Ministry sections of the Annual Report. She offered her gratitude to the teachers and substitutes of the Faith Formation classes. She acknowledged the dedication and efforts of Redeemer's Youth in their service projects, in their commitment to helping those who are facing food insecurity, in fundraisers such as the Pancake Supper and Living Nativity bake sales, and in their participation in the 2025 mission trip to Niagara Falls, NY. The 2026 mission trip will be to Wilmington, North Carolina. A Confirmation Retreat will be held in late March.

Grace called on adults to help strengthen and expand existing programs by volunteering to provide supervision as needed, and Karen Miller encouraged parents to consider participating in youth ministry and trips.

Ministry Highlights - Social Outreach -- Food Insufficiency Ministries:

Stephanie Hunter referred congregants to the Social Outreach Ministry section of the Annual report, and highlighted the following efforts of Social Outreach ministries:

- Little Pantry--provides food to our neighbors in need and serves numerous people every day.
- Share of McLean--serves as a community collection site for food donations.
- BritePaths--provides emergency short term food assistance, financial assistance, and support for children around Fairfax County.
- Second Story--provided Holiday food baskets to 29 families in 2025, enough to feed 174 people.
- Youth Trip to Niagara--supported those facing food insecurity in New York in Summer 2025.
- Rise Against Hunger--raised over \$85,500 and packaged 213,840 meals which were shipped to Timor-Leste in November 2025.
- Financial Contributions to World Central Kitchen, Lutheran World Relief.

Stephanie acknowledged the efforts of Kim Wenk, Joan Durman, Deanna Heier, Judy Kuhagen, Tricia Engle, Paula Green, Cindy Morrow, Roberta Pittman, and many others for their participation in the endeavors listed above.

Karen Miller invited those in attendance who have volunteered for these ministries to stand and be acknowledged by the congregation.

Action Item - Recommendations for Council from the Nominating Committee:

Pastor Core offered a prayer of discernment prior to the voting action-items on the agenda.

Karen Miller thanked departing members of Council (Lena Martikainen, Sarah Getter, and Youth Representative Victoria) and presented the names of candidates recommended for Council from the Nominating Committee as listed in the agenda:

- Sara Egeland (First year of 3-year term)
- David Broderdorf (First year of 3-year term)
- Chris Hernadi (First year of second 3-year term)
- Gene Morrow (First year of second 3-year term)
- Megan Kratz (First year of second 3-year term)
- Tyler Posey (First year of second 3-year term)
- Anna (Youth representative -- 1-year term)

A motion was made from the floor by Karen Detweiler to accept the nominees. The motion was seconded by Charlie Brown. The slate of candidates was approved unanimously.

Action Item - Recommendation for Endowment Committee:

Karen Miller thanked departing member Mary O'Brien and presented the candidate recommended for the Endowment Committee as listed in the agenda:

- Lara Paukovits (First year of 3-year term)

A motion to accept the nominee was made by Tricia Engle. The motion was seconded by Matthew Kratz. The nomination of Lara Paukovits was approved unanimously.

Action Item - Adoption of Updates to the Constitution:

Karen thanked Judy Kuhagen, Tyler Posey, and Sarah Getter for their efforts in proposing updates to the Constitution to align the document with ELCA Model Constitution requirements and with established current practices at Redeemer. The proposed updates to the Constitution were made available to the Congregation in hard copy and as a link to the newsletter in advance of the annual meeting.

Action Item - Adoption of Updates to the Constitution (Required Updates):

A motion was made to accept the proposed required updates by Ron Kutscher. The motion was seconded by Chee Lee Leong. In response to a question posed by congregant Charlie Brown, Karen Miller confirmed that language in the required updates came directly from the Model Constitution. The required updates to the Constitution were approved unanimously.

Action Item - Adoption of Updates to the Constitution (Non-Required Updates):

Following adoption of the required updates, Karen Miller reviewed the following non-required updates to the Constitution:

- The addition of language allowing for meetings to be held via Zoom.
- The addition of language formalizing the combined efforts of the Financial and Audit Committee.
- Standardized and consistent language to refer to the Congregation Council.
- The addition of language to include the Child Protection Committee with references to the Child Protection Charter.
- The addition of language aligning the Constitution Title name with Redeemer's legal name.

A motion to approve the proposed non-required updates was made by Charlie Brown. The motion was seconded by Kim Wenk. In discussion, congregant Harold Hofstad noted the historical and contemporary associations with

the term “evangelical” and invited congregants to be mindful of how the term is interpreted outside of the church when it is used in Redeemer’s public messaging.

After discussion, the updates were approved unanimously. The updates will be ratified a second time at the next annual meeting per constitutional requirement.

Action Item - Adoption of 2026 Budget:

Rob Wenk presented the proposed 2026 Budget. Rob noted Redeemer’s practice of basing budget contribution projections on actual contribution levels from the preceding year. Rob emphasized that in 2026 Redeemer will require additional contributions to meet anticipated expenses.

The motion to approve the proposed budget was made by Cindy Morrow. The motion was seconded by Tricia Engle.

In response to a question posed by congregant Charlie Brown, Rob agreed to continue to keep the congregation informed of the budget bottom line over the course of the year and suggested that certain discretionary spending items could be deferred in the event of a shortfall. Charlie urged Rob and Council to communicate early, and through Temple Talks in addition to written notices, if contributions appear to be falling short of actual or anticipated expenses.

In response to a question posed by John Teitman, Karen confirmed that the operating budget was designed to keep the ministries moving at current levels, and that the mortgage payments represent commitment to growth through the construction and exterior grounds projects.

In response to a question posed by Johannes Wiklund, Rob clarified that facility use income largely comes from gym, fellowship hall, and music room usage by outside organizations, and music rooms.

After discussion, the proposed 2026 Budget as presented in the Agenda was approved unanimously.

Discussion Item - Update on Building Project and Path Forward:

Rob Wenk guided the congregation through activities of the Building Project as detailed in the Building and Grounds Committee Report:

- **Accomplished to date.** Rob noted that turnover from construction of the classroom wing was completed in December, and renovation construction of the office wing began as scheduled on December 15. County approval of the site plan for the Columbarium and playground renovation was granted.
- **Financial Review.** Rob expressed his appreciation to all those who have pledged and contributed towards the capital campaign. New pledges are still being received and collected, which will help Redeemer to reduce borrowing requirements and costs.
- **Path Forward.** Bids for the exterior work came back much higher than expected, due to annual rising costs and additional county requirements for storm water management and tree protection. Architects, engineers, and general contractors are revising current plans, and the team will review to propose a solution.
- **Discussion.** In response to a question posed by Charlie Brown, Rob confirmed the commitment to proceed as planned with both the Columbarium and the playground area as approved by the Congregation at a prior annual meeting. It was further noted that the Columbarium provides the potential to produce income, which can help to manage costs of the entire project.

Adjournment:

President Karen Miller asked the congregation to proceed with adjourning the meeting. Hearing no objection to adjournment, Pastor Core closed with prayer.

Council Meeting Guests: Brian Doyle, Redeemer Evening Facility Host.

Call to order. Karen Miller called the meeting to order at 7:34

Farewell to Brian Doyle, Redeemer Facility Evening Host. Evening Facility Host Brian Doyle announced to Council that he will be taking a new position outside of Redeemer, which will begin in six weeks. He will continue at Redeemer in his position as Evening Host until then. He expressed his humble gratitude for his experience at Redeemer and will hold the entire community in his prayers. The Council thanked him for his dedication and emphasized the importance of the work that he has done and continues to do here.

Welcome New Council Members. David Broderdorf and Sara Egeland and Youth Representative Anna were welcomed to their first meeting of Council after their election by the Congregation. Council members introduced themselves to the new members.

Opening Devotions. Pastor Core led opening devotions with a quote from *Wishful Thinking*, by Frederick Buechner: *“The place God calls you is the place where your deep gladness and the world’s deep hunger meet.”* In their discussion, Council members offered examples of individual “deep gladness” of the “world’s hunger.” Pastor Core invited Council members to reflect how the Redeemer community could house the intersection of the two.

Approval of Minutes. Minutes from the meeting were previously approved by email.

Adoption of Agenda. The agenda, as emailed in advance of the meeting, was approved by the Council with the addition of the announcement from Brian Doyle as mentioned above.

Executive Committee Summary. The Executive Committee met on March 4 and talked about the items on tonight’s agenda. In addition, there was a discussion of the need to explore ways to broaden Redeemer’s Christian Education program for both adults and youth. It was noted that this has been identified in the survey launched by the Transition Committee, as well.

Discussion Item: General Updates. Pastor Core mentioned that on Sunday, March 15, she and Pastor John Teitman will meet informally with potential new members. Pastor Core invited current members to attend these conversations, which will be held after the 11:00 service, and to contact her if available.

Election of Officers. Council unanimously approved the Council members below to serve as Officers and as At-Large Executive Committee member.

- President: Karen Miller, for a second one-year term
- Vice President: Sabine Detweiler, for a second one-year term.
- Secretary: Chris Hernadi, for a second one-year term.
- Member at-large of Executive Committee: Annabelle Allard

It was noted that Annabelle Allard agreed prior to the meeting to be considered as Member-at-Large of the Executive Committee, and that the position of Treasurer, currently held by Steve Bott, was elected by the congregation at the Annual Meeting as required by Redeemer's governing documents. It was further noted that, because an individual may serve as President for no more than two consecutive years, Karen Miller will not be eligible to serve as President in 2027.

Treasurer's Report. Treasurer Steve Bott presented the 2026 Financial Summary through February 28, which was made available via email prior to the meeting. It was noted that Redeemer has a \$30,00 surplus as of February 28. Given that the surplus includes the \$10,000 surplus from 2025, Redeemer's contribution rate is slightly behind the levels reached in February 2025. In light of this, Karen Miller reiterated the commitment expressed in the Annual Meeting to keep the congregation updated on the budget status throughout the year. Pastor Core and council members considered ways to reframe the discussion of money within the congregation to encourage individual reflection on contribution intentions to the church.

Action Item: Endowment Committee Request: On behalf of the Endowment Committee, Karen Miller asked for a motion to approve the Endowment Committee's request to issue a \$5,000 grant to Second Story, as detailed by Endowment Committee liaison Gene Morrow.

The motion to approve the Endowment Committee's request was made by Megan Kratz. The motion was seconded by Sabine Detweiler, and the motion passed unanimously by Council.

Discussion Item: Transition Team Progress. Karen Miller reported that the Transition Team will conduct small-group meetings through March and will hold topic-specific small group meetings from after Easter and into May. The first meeting was held March 8. Subsequent meetings are scheduled for March 10 and March 19. Pastor Core expressed her appreciation of the depth and seriousness of the conversations that were held at the first meeting. The aim of these meetings is to provide coherent and substantive material for the Mission Site Profile, which will be submitted to the Synod as part of the Call process.

Discussion Item: Council Liaison Assignments. Karen Miller described the responsibilities of being a Council Liaison, and Council members agreed to serve as Liaisons as listed below:

- Congregational Life: Lee Cronin
- Endowment Fund: David Broderdorf
- Finance and Administration: Steve Bott

- Child Protection: Karen Miller

Pastor Core offered her assistance to encourage more participation in these committees and ministries.

Discussion Item: Nominating Team for Call Committee. Karen Miller asked Council to reach out to her with suggestions for a Nominating Team for the Call Committee. It was noted that the nominating team would ideally consist of two individuals from Council, and two individuals outside of Council. Karen reminded Council that the Call Committee would eventually consist of 8 individuals, some of whom could be from the Transition Team, some of whom have already expressed interest in serving on the committee.

Discussion Item: Synod Assembly Attendance. The DC Synod Annual Meeting will be held on June 6. Redeemer is allotted seven slots plus one additional individual (a person of color or who has English as a second language) who may attend to represent Redeemer. Karen noted that 3 members of the Congregation have already expressed interest in attending.

Ministry Reports: Youth Ministry. Anna reported that Grace Howie will follow up soon with the Youth Committee to provide an update about future events.

New Business: None.

Construction Project Updates from March

The recent construction activity in the office wing includes putting up new drywall, installing the ceiling grid, hanging new light fixtures, moving fire sprinkler pipes to accommodate the new HVAC ductwork, pulling data cabling for the phone, security and computer systems, installing new electrical outlets, balancing the HVAC system, and creating a new directional sign package to go out to bid.

The features and benefits soon to be realized in the remodeled office wing are improved offices with better sound privacy, remodeled public restrooms, ability to individually control heat/cooling in each room, improved space utilization in the robe room, larger meeting space in the library, separate area for member mailbox access and copier use, improved entryway security along with energy efficiencies, and a separate secured computer equipment room.

When construction finishes in the office wing, the pastor and the staff will move from their temporary offices back into their renovated offices in the other wing. The renovated restrooms will be open again and members assisting with worship will be able to use the robe room. The library will be available for booking meetings starting in May. There will also be new signage going up for each room or office and to direct people in the hallways.

The financial update that was provided at the congregational annual meeting is as follows: So far \$1.3M has been given to the Capital Campaign for all the project areas. There is approximately \$71k of pledges from members yet to be received, although many of those are new pledges for 2026. So far \$936k has been spent on the interior building renovations, with approximately \$536k yet to be spent to complete the interior work. At that time, there would be approximately \$450k of those costs that will be financed internally from our reserves to delay the need to use borrowed funds. This is something that Redeemer has done in the past with other building projects to save on loan interest costs.

Reflections from the 2026 Confirmation Retreat

My confirmation trip to Mar-Lu Ridge ended up being such a good day. I woke up around 6:20, and before heading to the church I stopped at McDonald's with my grandpa, which made the morning way better. For camp activity time, me and Ella picked the Flying Squirrel, where you get clipped into a harness and everyone else pulls you up into the air. It was so much fun and definitely the right choice. The views at Mar-Lu Ridge were so insane. Everywhere you looked, the hills and valleys stretched out forever. The sky felt huge and bright and the air was so clear it almost didn't feel real. The view from the chapel during closing worship was my favorite it was peaceful and beautiful in a way that made you want to just stand there and take it in. Even though our group was tiny, the trip made me feel more connected to my faith and the people I was with. It ended up being one of the best days I've had in a while.

I met a lot of people today. One knew over fifteen things to with a plain deck of cards. We went back inside to start our first confirmation session and Pastor Josh lead it!! (He misses us a lot and says hi to Redeemer). He told us about how we formed from the dirt in the ground and about the breath of life. Then they brought out air dry clay and we got to mold things that represented us. My items were a skateboard and two dice (that looked marbled). Once we were done, we had free time, which meant we could do what we wanted. Me and Josephine went to play volleyball with our chaperones. (P.S. me and Grace won 17-13, then we went to 25 and ended 25-23). After that I went to play with and meet the other kids from the other areas. The we went to lunch, and boy was that good. Shredded beef sandwiches, fruit, cookies and some juices (I devoured it all). After that we went up the hill together to the main room so we could go to our activities!! Me and Josephine did the flying squirrel which was interesting. It wasn't a ropes course, instead it was getting pulled up in the air by the other kids and hanging there for 3 seconds, then going back down. It was fun! After that was done we went back to the other building for our second confirmation session. It was interesting and talking about who impacts us and who we impact in our lives. Then we went to the chapel where we sang and said our praises to the Lord. Afterwards we said out goodbyes, posed for a photo and left.
