## **FELLOWSHIP CHURCH MOM 2 MOM SALE TABLE RENTAL AGREEMENT**

### Details for Mom-2-Mom Sellers:

1. The Mom-2-Mom sale provides an opportunity to buy/sell gently used children's clothing, equipment, toys, maternity clothes, and related furniture. It is not intended for household items or items not related to this specific sale.
2. Each booth is 10' x 10' and includes one round table. Should you require additional tables or rectangular tables they can be rented for a \$6.00 charge per table and are available on a first-come basis. Also, please be sure that all items fit within your booth and do not protrude out into the walkways.
3. Should you reserve a booth after the deadline, the fee is \$25. Within that time period, tables may or may not be available but the fee is still \$25.
4. You are allowed to bring racks and other items to display your merchandise, but they must fit within your booth.
5. We do have a specific area for larger items and the cost for each large item is \$1.00, whether it sells or not. Each large item will be separately tagged with your name and booth number. Payment for these items will be at a checkout table within the designated area.
6. Registration and set-up will be:  
**Friday, March 9, from 4:30 p.m. – 6:00 p.m. and**  
**Saturday, March 10, beginning at 7:00 a.m.**  
In order to determine which space is assigned to you, please register first.
7. Pre-sale shopping for sellers will be:  
Friday, March 10, from 6:00 p.m. – 6:30 p.m.
8. Items should be tagged (priced), clean and in good working condition. They should be neatly categorized into sizes for ease of selling.
9. Please help us advertise the event by word of mouth or if you're willing to circulate some fliers let us know and we will make those available to you. If you have a Facebook account, you are welcome and encouraged to list it on your page! The more people we all tell, the more shoppers for everyone!
10. Bring a money box and money to make change (plenty of dollar bills).
11. Bring an ample supply of bags.
12. There is a \$30.00 NSF charge. In the event of an NSF check, you will be required to pay cash for both the space rental and the NSF charge. Your table rental will not be secure until it is paid for.
