Give us the ability to adapt to the cultural, economic and social changes that occur in the neighborhoods we serve.


Receive our prayer, O God.

Trinity Lutheran Church Annual Meeting January 22, 2023

The Annual Meeting of Trinity Lutheran Church was called to order at 10:20 am on Sunday, January 22, 2023 by President Michele Stewart. The meeting was held in-person in the sanctuary and by Zoom. Attendance was taken by signature on paper and by preregistration on Zoom. There was a quorum with 96 present.

The agenda was approved with a Peggy Olson/Kevin Benson motion.

Rev. Dr. Jeanette Bidne led devotions with a liturgy printed in the annual report.

The minutes from the annual meeting held on January 30, 2022 were approved with a Dave Pirsig/Terri Wells motion.

The Treasurer's Report was given by Office Administrator Donna Perryman. Donna reported that 2022 was a busy year for Trinity! Donna reported that most all accounts that had been at Wells Fargo have now been transferred to First Bank Blue Earth, due to the closing of the Blue Earth Wells Fargo in 2020. Donna also noted she will be compiling a set of detailed explanations of the accounts so that she is not the only person with the knowledge of the how and why of the accounting system, to make for a smoother transition for future retirement. The Treasurer's Report was approved with a Clair Nassen/Jim Beattle motion.

President Michele Stewart (report on page 7) noted it has been a year of blessings and challenges. She noted Trinity has been resilient and hearty in our support and dedication to our faith home and family. We have come together and made it through many challenges of covid, purchased and implemented a live stream camera system, and hired a full time education/youth coordinator. We are making strides on paying the loan for our live stream project, as well as the line of credit which has not grown in many months', thanks in part to the generous gifting by our members. Our youth program is becoming stronger than ever! Michele was honored and humbled to be Council President for 2022 and is excited to see what 2023 brings for each of us as God's children. Michele thanked everyone for the opportunity to serve as President in 2022.

The committee reports were approved as written on a Gary Holmseth/Sue Olson motion.

Pastor Rev. Dr. Jeanette Bidne's noted (report on pages 8-9) a year of dramatic change for her family, with the birth of their son, Benjamin, and also the move from Vernon Center to live on her paternal grandparent's century farm. In addition her husband, Dan Foster, is now the chaplain of St. Lukes. Navigating change in our lives leads us to think about how we perceive our values especially when time and energy can sometimes be limited.
