I understand my volunteer assignment may be terminated at any time at the discretion of the Youth Pastor's, Eldership board, or Pastoral team of Eastgate Creative Christian Fellowship. As a condition of being accepted as a volunteer with Sync, I agree to maintain a high degree of ethical standards and be law abiding in all respects. Should one be required, I agree to a background and/or reference checks to determine my suitability to volunteer at Sync Student Ministries. I understand that, as a Youth Leader, Student Leader, or volunteer, I am representing Sync Student Ministries (but I am not an employee) and will adhere to the guidelines set forth by the youth ministries' pastoral staff. I understand that if I am unable to fulfill my duties as a Youth Leader, Student Leader, or volunteer, or have any conflicts I will report any such problems to the pastoral staff as soon as possible.

Volunteer / Staff Code of Conduct

Youth ministry staff, leaders, interns, and volunteers must comply with this Code of Conduct throughout their service to Sync Student Ministries. Compliance with this Code of Conduct is a condition of continued service with Sync Student Ministries and Eastgate Creative Christian Fellowship. If any youth program staff, leaders, interns, or volunteers violates the following standards, this will be grounds for immediate termination.

1. Sync personnel must safeguard and hold confidential any information gained through administrative duties involving supervision or personnel or other information identified by Sync as being confidential.
2. Sync personnel must not report to serve or represent Sync in an official capacity under the influence of drugs or alcohol nor be in the possession, sale, or delivery of controlled substances.
3. Sync personnel may not strike, shake, spank, or verbally abuse any adult or youth client as a means of discipline or otherwise.
4. Theft of property or funds and/or the misapplication of Sync Student Ministries funds are breaches of the code of conduct.
5. Falsifying application material is a breach of the code of conduct.
6. Sync personnel must not be alone with a student / minor at any time.
7. Sync personnel must not engage in sexual activity with students.
8. Sync personnel must report, in confidence, any suspected violation of the Code of Conduct to Sync's pastoral staff.
