INVOICES

Digital invoices are automatically sent out by email on the 20th of each month to request payment for the coming month's costs. Payment is due on the 1st day of each month. Penalties for delinquency begin on the 6th day of the month.

AUTOMATIC PAYMENTS

Automatic payment plans are easily available and strongly encouraged. Families who have 2 or more late payments at any time during the duration of the school year may be required to enroll in automatic payments for the remainder of the year as a condition of enrollment.

WITHDRAWAL POLICY

Enrollment at MBCS constitutes a contract for at least each new month. If a student's enrollment comes to an early end for any reason, a 30 Day notice form must be completed and submitted in order to refund any portion of payments already collected for a month. Any outstanding balance of tuition & fees will be immediately due. All parents must sign a financial agreement prior to being enrolled.
