

ANNUAL MEETING MINUTES - March 18, 2012

Call to order: The meeting was called to order by President Nell Bigley at 9:45am.

Opening Prayer: Was given by Rev. Dr. Cathy Northrup.

Approval of the Annual Meeting Minutes: It was moved by Don Gibbs and seconded by Pat Hemmer to approve the minutes of the Annual Meeting held on March 20, 2011.

Remarks by the President: President Nell Bigley introduced the current trustees and committee chairs. She thanked the many persons who have been so instrumental in the growth of our Church. She especially thanked Sherrill Beck for her work with Stephen Ministry and John and Cary Pasnau who have taken over as leaders of Stephen Ministry. Todd Korb has worked tirelessly on computer problems in the Church office, and Don Terwilliger has designed the new look for all our brochures and stationary. Connie McGivern takes care of many "unseen" jobs, and Tommy Wojtas works his magic with the sound system. Our webmaster – Kathy Hofstrom, and our wonderful choir and director, Tom Wojtas, and our bell choir and director, David Lowell were also thanked. Other activities critical to the success of the Church are the work of the Finance and Endowment Committee. The Memorial Gardens were dedicated in 1990 and David Lowell has been working to clean and repair the Gardens. We voted on a more inclusive name and became the Community Church of the Verdes. Our office administrator, Beth Biebrich, has done an outstanding job. The Bylaws have been reviewed and updated. And we welcomed our new Pastor in August, Rev. Dr. Cathy Northrup.

Endowment Fund: Lee Hamilton talked briefly about our endowment fund of \$157,000. He encouraged including the Church in estate planning.

Treasurer's Report: Maggie McMillan presented the budget. We do not have adequate reserves for the facilities account and a Capital Improvement Campaign will be initiated very soon.

Nominating Committee: Dave Bakke presented the nominees for the Board of Trustees to replace retiring members, Chuck Ingwalson, Anne Carrier, and David Lowell. The new nominees are Peter Mattingly, Todd Korb, and Wally Lange. Dottie Mason made the motion to accept the nominees, seconded by Bill Hoffman and passed with voice vote. Don McGivern presented the retiring board members with Certificate of Thanks.

PASTOR'S REPORT

Dear Friends,

Last year in this report, I shared with you news on what I believe are my primary duties here as Pastor: preaching, teaching, and pastoral care, as well as a bit of administration at the church and community involvement. I continue in those duties with great joy.

Worship leadership is a very important part of my position. I value planning and leading worship with a great colleague, Tom Wojtas. She has enjoyed several career paths and lengthy service in charitable fundraising primarily for abused women and children. She trained and served as a Court Appointed Child Advocate for many years in Indianapolis. While living in Pinnacle Peak Country Club, Bob and she were active members of Pinnacle Peak Presbyterian Church. Once here, they joined the RV Community Church. Nell served on the Architectural Committee of the Rio Verde HOA; Fellowship Committee and Secretary of the Community Church Trustees Board prior to being elected chair; RVCC Women's Nine Hole Golf Group Board as well as RVCC Grounds and Handicap Committee. She just completed a four year term on the Lake Edgewood Conservancy District Board (IN) and saw the completion of a long needed \$1.7 million flood control spillway and dam with minimal funding from the residents. The project is now receiving many awards from various groups for design, construction, etc. Her deepest passion is her family, grandchildren, Indiana University basketball, Notre Dame football and hoping to make at least a little bit of difference in the lives of the neediest.

Curt Hage Born and raised on a farm in the Red River Valley of eastern North Dakota and has instilled rural values and a conservative view of life. He was educated in a rural grade school, and graduated from Augustana College with a degree in Business Administration. The completion of his MBA at the University of South Dakota provided a solid foundation to pursue his business career at Home Federal Savings Bank in Sioux Falls, South Dakota. Since discovering the Verdes on a golf trip in 1993, it has been a dream of theirs to live in this community. They rented for several years before buying their home in Tonto Verde in 2010. They live in Sioux Falls, SD in the summer and Tonto Verde in the winter.

FINANCE COMMITTEE REPORT

The Finance Committee was newly established in February of 2012. We have had a full and productive year thanks to the generosity of the congregation.

Budgets: Our first order of business was to recommend revising the 2012 budget to include a figure of \$135,000 for depreciation to reflect the total cost of the church operations. We also developed and recommended the budget for 2013.

Capital Campaign: Realizing that there were some substantial expenditures needed, especially due to structural issues with the roof and stucco, the committee recommended to the Trustees the establishment of a capital campaign with a goal of \$500,000.

Endowment Fund: An educational brochure was developed and placed in the pews explaining the Endowment Fund. The manager to the fund was changed for a considerable savings. Per our Endowment Policy, we have repositioned the fund and a contribution of 5% of the average value of the last three years was made for the Trustees discretion near the end of 2012. A similar recommendation will be made in 2013.

St. Dominic Catholic Mission Lease: The church negotiated a five year lease with St Dominic Catholic Mission for their utilization of our facility. Two members of St Dominic Catholic Mission's finance committee and two members of The Community Church of the Verdes' finance committee negotiated a mutually acceptable five year contract which became effective July 1, 2012.

Audit: Three members of the finance committee served as the audit committee which presented a very comprehensive report to the Trustees

Insurance: The insurance coverage was reviewed and the agent was changed based on competitive bids. The insurance requirements for individuals and organizations using the church, was reviewed.

Treasurer's Report: Under separate cover you will see the Treasurer's Report for 2012. Our special thanks to Maggie McMillan who has served tirelessly in this position.

Financial Reports: The Finance Committee monitored monthly financial reports as developed by the Treasurer.

The following deserve special recognition - they make the Treasurer's job so much easier - our entire Finance Committee, Administrative Assistant, Beth Biebrich, Accountant, Kirsten Sundahl, Assistant Treasurer, Dave Bakke and all the weekly volunteer tellers who help us so much with our record keeping during the year. Thank you all.

CAPITAL CAMPAIGN REPORT

In the Spring of 2012, responding to a directive from the Board of Trustees, based on a recommendation of the Finance Committee, a committee was formed to undertake a Capital Campaign fund raiser with a goal of \$500,000. The Committee of Anne Carrier, Dean Eggebraten, Jim Justus, Dick Larson, Marilyn McQueen, Peter Mattingly, Bob Nyman, Carolyn Terwilliger and Lee Weinberger, Chair, began its work in late spring of 2012 with a goal of completing the campaign by March 31, 2013.

Thanks to the generosity of our congregation, the \$500,000 goal was achieved and exceeded before the end of the year 2012. The major portion of the funds raised will be spent correcting serious structural problems on the sanctuary and chapel as well as support of our Music Ministry by replacing our 100 year old grand piano. Thank you to all contributors.
