



ADULT RELEASE, WAIVER & INDEMNITY AGREEMENT

IT IS THE INTENTION OF (NAME) BY THIS AGREEMENT TO EXEMPT AND RELIEVE NEW LIFE COMMUNITY CHURCH OF FAIR OAKS, INC. AND ITS OFFICERS, AGENTS, SERVANTS OR EMPLOYEES FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH OF (NAME) CAUSED BY ANY ACT OF NEGLIGENCE OF NEW LIFE COMMUNITY CHURCH OF FAIR OAKS, INC. AND ITS OFFICERS, AGENTS, SERVANTS OR EMPLOYEES while at Tahoe Valley Campground.

For and in consideration of permitting (NAME) to observe or use any facility or equipment of Tahoe Valley Campground or engage in and/or receive instruction in any activities or activities incidental thereto—SOME OF WHICH MAY INVOLVE DANGERS AND RISK OF BODILY INJURY—at Tahoe Valley Campground, in the city of South Lake Tahoe, County of Lake Tahoe, and State of Nevada, from Thursday, June 11th through Sunday, June 14th, 2026, I hereby voluntarily and absolutely release, discharge, waive and relinquish any and all loss or damages or actions or causes of action for personal injury, property damage, or wrongful death occurring to (NAME) as a result of (NAME) observing or using facilities or equipment at Tahoe Valley Campground or engaging in or receiving instructions in any activities—SOME OF WHICH MAY INVOLVE DANGERS AND RISK OF BODILY INJURY—or in activities incidental thereto wherever or however the same may occur, and for whatever period said activities or instructions may continue.

I agree that, in the event any claim for personal injury, property damage, or wrongful death shall be prosecuted against New Life Community Church of Fair Oaks, Inc. or its officers, agents, servants or employees, I, the undersigned, will indemnify and hold harmless New Life Community Church of Fair Oaks, Inc. and its officers, agents, servants or employees from any and all claims or causes of action by (NAME) or by any other person or entity, by whomever or wherever made or presented, and under no circumstances will I, the undersigned, (NAME)

present any claim against New Life Community Church of Fair Oaks, Inc. and said persons for personal injuries, property damage, wrongful death or otherwise, caused by any act of negligence by New Life Community Church of Fair Oaks, Inc. and said persons.

I represent that I have read this Release; have requested and have been provided with, or have requested and declined advisement on, the potential dangers/risks of engaging in the observation, activities or instruction offered; assume all risks associated with such dangers and risks; and I am fully aware of and understand the terms and the legal consequences of the signing of this Release. I intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law and if any portion of the Release is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
