Statement of Faith

The DuBois Christian Schools' Committee and Administration urge parents to recognize their scriptural responsibility (Deuteronomy 6:1–9, Psalm 78:5, 6, Proverbs 22:6) to provide their children with a Christian education, and to understand that the primary responsibility for this task rests with the parents (Ephesians 6:4). DCS was founded, and continues to operate upon biblical values, and the desire and commitment for Bible-believing Christian parents to enroll their children in an intentionally Christian environment. DCS will consider admission for students from any family who, despite their religious background or beliefs, is willing to support the DCS's philosophy of Christian education, student conduct requirements, Parent's Pledge, and who is willing to allow their children to be educated and influenced in an intentionally Christian environment. Continued enrollment at DCS is contingent upon this same understanding and support.

DuBois Christian Schools stands firmly upon the historical truth claims and moral foundations of Christianity. This includes, but is not limited to, the biblical definition of marriage as a covenant relationship between a man and a woman, the attendant boundaries of sexuality and moral conduct, and the clear biblical teaching that gender is both sacred and established by God's design. Parents, or the legal guardians, who choose to enroll their children at DCS are agreeing to support these and other basic biblical values derived from historical Christianity, and the relevant Christian positions embraced by First Baptist Church of DuBois, under whose authority this school rests. Parents understand and agree that DCS will teach these principles and biblical values.

We believe the Bible to be inerrant, verbally inspired and produced by the Holy Spirit. We believe the Bible to be the only rule of faith and practice.

We believe there is only one living and true God and there are three persons: Father, Son, and Holy Spirit – equal in every divine perfection, essence and power.

We believe the deity of the Lord Jesus Christ, born of the Virgin Mary, and that He is both the Son of God and God the Son. We believe in His substitutionary death on the cross for our sins; His bodily resurrection; His ascension to the right hand of the Majesty on high; and His premillennial, personal and visible return to earth for His own.

We believe that the Holy Spirit is a Divine Person, the Administrator of the things of God through believers in the world. He convicts of sin, righteousness and judgment.

We believe that God created the heavens and the earth in six literal days, including all life, each after its own kind, by direct act and not by a process or evolution. We believe that by voluntary transgression, Man fell from his sinless state and is therefore under the just condemnation of God without defense or excuse.

We believe in the reality of Satan, that he is the author of all the powers of darkness and is destined to the judgment of an eternal place in the lake of fire.

We believe in a heaven of everlasting blessedness for all who have been saved and the everlasting, conscious suffering of the lost (those who have not believed in and received the only begotten Son of God) in the lake of fire.

We believe in the imminent, pre-tribulational rapture of the saints; the visible and glorious return of Christ with His saints, who judges the nations and established a literal kingdom on earth for one thousand years. Thereafter, the unbelieving dead are raised to be judged at the Great White Throne for eternal punishment in the lake of fire.

Electronic Device Student Parent Contract for DCS

To be completed by all 7-12th grade students and parents, and any student who will be bringing an electronic device to school at any time regardless of grade level

I understand that any opportunity to use an electronic device (school-owned or personal) and the network (wired or wireless) at DuBois Christian Schools is a privilege. During the school day, I am only allowed to use an electronic device during specific teacher-conducted academic activities, or during the lunch period green zone. At all other times, all personal electronic devices and accessories must be put away. I am personally responsible for my actions, and will be held personally accountable should I violate any of the following terms:

- I agree to place my device in the teacher provided pocket chart holder at the beginning of each class period for safety as well as for elimination of distractions.
- I will only use my personal electronic device when directed to do so by my teacher for academic purposes.
- I agree to not engage in any electronic communication or recording (including, *but not limited to*, phone calls, social networking, videos, chat, texting, pictures, music, instant messaging, web surfing, email, blogs, etc.) during the school day at DCS except during my designated lunch period.
- I agree to not view, send, listen to, or access material which is considered abusive, pornographic, sexually explicit, obscene, threatening, disrespectful, or generally offensive on an electronic device.
- I agree to not use an electronic device in such a way that it harms other people or their work.
- I agree to not purposely damage or alter the DCS information network or computer systems. (This includes, *but is not limited to*, attempts to change programming settings, operation systems, to load or download any software programs, or to delete existing programs.)
- I agree to not access, view, or copy other people’s private folders, files, or work without permission.
- I agree to not give out personal information or school information over the internet.
- I agree to not view or access Internet sites that my teacher or classroom supervisor does not consider appropriate.
- I agree to be careful to not waste resources such as paper, ink and toner.
- I agree to inform a teacher, administrator, or classroom supervisor immediately if I accidentally access inappropriate material, or witness another student violating any of these guidelines.

I understand that violations of these guidelines, may result in a corrective consequences including, but not limited to:

- Confiscation of a personal electronic device with pickup by student or by parent after school
- Temporary or permanent loss of electronic device use privileges at DCS
- Demerits/ Detention
- Other forms of discipline deemed necessary by DCS administration
