The parents or guardians understand that they are signing for the minor(s) listed on this form and the signature is for both a medical and liability release.

-SCOPE OF EVENTS: My child has permission to attend all church sponsored youth/children's activities, including, but not limited to, the following list: Cook-outs, boating, water sports (including water skiing, wakeboarding, banana boating, kneeboarding) basketball, roller skating, roller-blading, skateboarding, broomball, games in parks, soccer, volleyball, softball, baseball, water parks, amusement parks, camping, retreats, repelling, whitewater rafting, rock climbing, hiking, biking, skiing and/or snowboarding, sports, concerts, Bible studies, miniature golf, etc. NOTE: If you desire to limit your child's participation in any event, please inform OPC in writing in advance of that event.
