**If you are not wearing an appropriate bathing suit you will be asked to change clothes by a leader.**

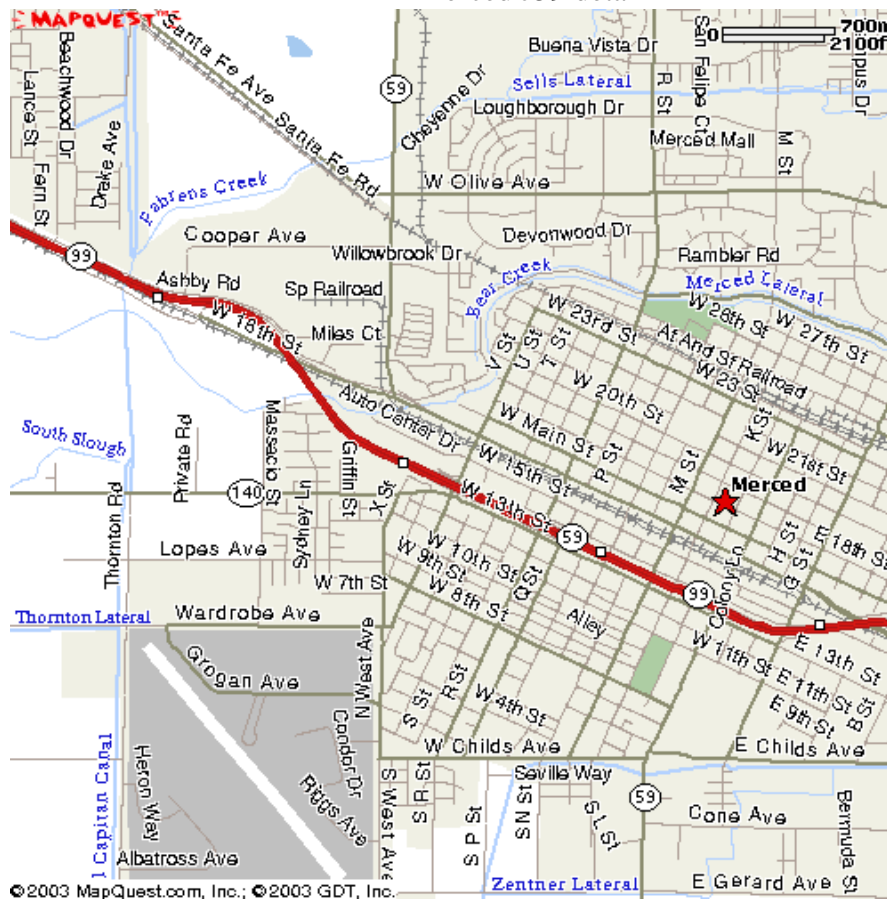

## Directions from CCC to Lake Tulloch

Directions	
1	Take Las Posas Rd. to Somis Rd. ( <b>hwy. 34</b> ) Turn Left (northeast) on Somis Rd.
2	Continue through Somis turn right on Los Angeles Ave. ( <b>hwy. 118</b> )
3	Follow the 118 (30.3miles) to <b>405</b> . Take the 405 North (1.9miles)
4	The 405 N turns into the 5 N, continue on the <b>5 North</b> .
5	Bear right onto <b>HWY 99</b> just before Bakersfield.
6	Exit HWY 99 on “ <b>V</b> ” St. (Route J59) in Merced turn right (North/East)
7	Turn Left after the railroad tracks on <b>J59 (See Note Below)</b>
8	Follow Route J59 North/East all the way up to the <b>108/120</b>
9	Turn Left (west) on the <b>108/120</b>
10	Follow HWY 108/120 to <b>Tulloch Rd.</b> (between Jamestown and Oakdale)
11	Turn Right and follow Tulloch Rd. to the Camp ground.

**NOTE: In order to stay on J59 a left turn must be made at the far end of the town of Snelling (don't blink).**

## Youth Overnight Contract

June 24<sup>th</sup>-29<sup>th</sup>

1. I will obey my leaders at all times. This is required for my own safety and the safety of others in the group.
2. I will honor the quiet time of 10:00 pm.
3. I will observe the male/female segregation rules which include: The women are not allowed in the men's camps, tents, sleeping bags, bathrooms, or other related areas; and likewise for the men. The students are not allowed to be alone with the opposite sex.
4. I will not bring drugs, alcohol, cigarettes, magazines, weapons, CD / MP3 players (even on the bus), radios, personal DVD players, fireworks.
5. I will not engage in any criminal or unlawful behavior.
6. I will be punctual for all scheduled meeting times, including meals and group times.
7. I will be responsible for my own things.
8. Breaking rules related to alcohol, drugs, sex, weapons, rule # 5, or gross disobedience will result in being sent home early at my own expense.

I also accept full responsibility for the cost of medical treatment for any injury suffered while taking part in the activity, which is over and above that which is covered by my insurance.
