CONSENT and ACKNOWLEDGEMENT

INITIAL

I grant permission to Redmond UMC to use photographs and/or video of my child taken at church activities in print and web publications, social media, and in other communications or promotions related to the mission of Redmond UMC.

I hereby agree to release and hold harmless Redmond United Methodist Church its, officers, employees, volunteers, committees and boards, from and against any and all liability, loss, damages, claims, or actions (including costs and attorney's fees) for bodily injury and/or property damage, to the extent permissible by law. This indemnification and hold harmless agreement shall include indemnity against all costs (including without limitation reasonable attorney's fees and court costs), expenses and liabilities incurred in or in connection with any such claim or proceeding brought thereon and in defense thereof.
