Benevolence: [\$27,200 in 2025]

- Purpose: To fulfill the needs of the community and congregation through benevolence.
- Activities: Support to the Synod and through it to the ELCA and related ministries
- Components: Synod Support and Community Support
- Note: We continue to set aside cash to help send kids to camp.

Worship and Music: [\$13,750 in 2025]

\$13,750 (+0%)

2.1% of 2026 Budget

- <u>Purpose:</u> To have multiple and diverse worship services which prepare our hearts to receive and act on the Word of God.
- <u>Activities:</u> Sunday worship, along with seasonal and special worship services including Advent, Christmas Eve, Lent, Thanksgiving Eve, and special music presentations.
- <u>Components:</u> Worship & communion supplies, copyright and other legal fees, piano/organ maintenance, music for Chancel Choir, New Spirit and Sounds of Joy, worship flowers, special musicians
- Note: Overall budget for Worship & Music is the same, but the individual line items have changed.

Christian Education: [\$14,050 in 2025]

\$16,050 (+14%)

2.5% of 2026 Budget

- <u>Purpose</u>: To provide individual spiritual growth outside a worship setting for everyone at RLC.
- <u>Activities:</u> Conduct Christian education, support Bible studies, maintain the library for personal study, provide for lay leadership education.
- <u>Components:</u> Sunday School for all ages, Confirmation materials and programs, VBS materials and programs, Bibles, library materials, leadership training
- Note: Increases are in Staff Continuing Education and Confirmation.

Youth & Young Adult Ministries: [\$12,000 in 2025]

\$12,750 (+6%)

2.0% of 2026 Budget

- <u>Purpose:</u> To provide programming and supplies for K-12 youth, college age and young adults and their families.
- <u>Activities:</u> Programming for Kids Club, Rally, and RYOT, Mission Trip, chaperones, retreats, other monthly or seasonal activities
- <u>Components:</u> Registration fees, Mission Trip, group activities, supplies, related expenses.
- Note: Increase is for RYOT in 2026.

Congregational Life: [\$5,100 in 2025]

\$4,700 (-8%)

0.7% of 2026 Budget

- Purpose: Enhance congregational life through a variety of ministries and fellowship functions.
- <u>Activities:</u> Stephen Ministry, Sunday morning coffee and donuts, new members classes, attendance at Synod Assembly, Fellowship events.
- <u>Components:</u> Training expenses, food, drinks, kitchen supplies, and registration expenses for Synod Assembly voting members.
- Note: Synod Assembly is in Arlington in 2026, thus costing less than 2025 (which was in Lubbock).

Facility: [\$88,200 in 2025]

\$92,745 (+5%)

14.4% of 2026 Budget

- <u>Purpose</u>: Manage and maintain the physical property and resources of the church.
- Activities: Maintain our building and property including upkeep and long term maintenance.
- <u>Components:</u> Lawn maintenance, utilities, major and minor building repairs, custodial services and supplies.
- <u>Note:</u> We expect no significant increases in utilities or custodial services, however we anticipate higher repair costs.

Administration: [\$52,558 in 2025]

\$50,228 (-4%)

7.8% of 2026 Budget

- Purpose: Manage the church office, human resource, and financial management of the church.
- Activities: Provide resources for the staff and congregation to carry out the ministries of RLC.
- <u>Components:</u> Office supplies, office equipment and maintenance, copier, telephone, internet, website, software licenses, liability and property insurance, workers compensation insurance, offering envelopes, postage, background checks, and interest on loan

Personnel Support & Payroll: [\$401,217 in 2025]

\$422,327 (+5%)

65.4% of 2026 Budget

- <u>Purpose</u>: Provide pastoral leadership and administrative support to the ministries of Resurrection Lutheran Church, and specific program leadership for Youth and Music programs.
- <u>Activities:</u> Provide leadership and support for all aspects of our life together including worship, pastoral care of members, administration, communication, volunteer support, and programming.
- Components:

 - o Full Time: Senior Pastor, Director of Music and Worship, Director of Children's Ministry and Education, Office Administrator.
