

**RELEASE OF LIABILITY AND ACKNOWLEDGMENT AND
ACCEPTANCE OF DANGERS, RISKS, AND HAZARDS**

In consideration of allowing my child to ride as a passenger in any vehicle owned by the First United Methodist Church of Graham, a Non-Profit Texas Corporation, its Representatives, Agents, Employees, Servants or Volunteers, herein referred to as (Releasee), I, _____, legal guardian of _____, herein referred to as (Releasor) for Releasor, their personal representatives, heirs, and next of kin, HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE RELEASEE FROM ALL LIABILITY TO RELEASOR, AND FOR ALL LOSS OR DAMAGE, AND ANY CLAIM FOR DAMAGE THEREFOR, ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN THE DEATH OF RELEASOR, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEE OR OTHERWISE WHILE RELEASOR IS A PASSENGER IN A VEHICLE OWNED BY RELEASEE, ITS AGENTS, MEMBERS, EMPLOYEES, VOLUNTEERS OR SEREVANTS.

RELEASOR AGREES TO INDEMNIFY AND FOREVER DISCHARGE RELEASEE FROM ANY LOSS, LIABILITY, DAMAGE, OR COSTS RELEASOR MAY INCUR ASSOCIATED WITH RIDING AS A PASSENGER IN A VEHICLE OWNED BY RELEASEE, ITS AGENTS, MEMBERS, EMPLOYEES, VOLUNTEERS AND SERVANTS WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEE, ITS AGENTS, EMPLOYEES, SERVANTS AND VOLUNTEERS OR OTHERWISE. RELEASOR ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE DUE TO THE NEGLIGENCE OF RELEASEE OR OTHERWISE WHILE RIDING AS A PASSENGER IN ANY VEHICLE OWNED BY RELEASEE, ITS AGENTS, MEMBERS, EMPLOYEES, VOLUNTEERS OR SEREVANTS.

Releasor expressly agrees that this Release of Liability and Acknowledgement and Acceptance of Dangers, Risks and Hazards document is intended to be as broad and inclusive as permitted by the laws of the State of Texas, and that, if any portion of the agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. Releasor states that Releasor has carefully read this document and understands the contents of this document and signs this document as Releasor's own free act.

RELEASOR FURTHER RELEASES RELEASEE FROM ANY CLAIM WHATSOEVER ON ACCOUNT OF FIRST AID, TREATMENT, OR SERVICE RENDERED TO RELEASOR BY RELEASEE, ITS AGENTS, MEMBERS, EMPLOYEES, SERVANTS OR VOLUNTEERS.

This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.
