



REGISTRATION & PAYMENT DETAILS

Review the Registration Details below to understand important dates, timelines, and policies.

REGISTRATION STEPS

- 1) Access and Review the *Network Handbook* before registering, in order to ensure you understand the process and policies. The *Network Handbook* is located on our website.
- 2) Register at fcswarriors.org/homeschool where you will be redirected to Fayette Baptist Church's Touchpoint system. This is the quickest and easiest way to register your family.
 - ☐ Enter your student's name and information during the first steps of the registration process (*parent's information will be provided at a later step*)
 - ☐ You may register multiple students at one time. After the first student, you can "add another person" to the registration.
 - ☐ Select each class that you want to register that particular student for
 - ☐ Pay your registration fee at the end of your online registration. Look over the details about payments below.
 - ☐ Registration is not complete until the registration fee is paid. You will receive an email confirmation.

Registration Details, Timelines, and Policies

1. **Early Registration:** January 30, 2026 - May 31, 2026. Register early to reserve and ensure a seat in a classroom! Students who withdraw from a class prior to May 31 will be issued a full refund with the exception of the non-refundable \$75 Registration Fee.
2. **Regular Registration:** June 1, 2026 - July 31, 2026. Regular registration is the same as early registration, but is subject to less refundable amounts in tuition and fees. Students who withdraw from a class from June 1 to July 31 will be subject to a partial refund with the exception of the non-refundable Registration Fee, Supply/Lab fees, and Class Fees.
3. You will notice there is a minimum number of students for each class to form. You will be notified on or around July 15 if a class does not form. All fees and tuition payments from that class will be refunded.

PAYMENT & FEES DETAILS

- ☐ The final step of the online registration is to select which Payment Option you would like to use.
- ☐ A \$75 non-refundable registration fee (per student) is due at the time of registration
- ☐ “Pay Deposit Only” option will only require you to pay the \$75 registration fee. You will receive a payment link in your confirmation email that you can follow to make additional payments of any amount as needed at any time. **Save this email and payment link for future use.**
- ☐ “Pay Full Amount” option will require you to make a full payment at time of registration.
- ☐ Payments may be made online via your paylink with two payment options: ACH bank draft (preferred) or by credit card.
- ☐ Cash and check payment options are also accepted at the FCS school office. There is a \$45 fee for returned checks.
- ☐ Your first payment of at least 25% of your total is due by April 1. 50% is due by June 1, 75% is due by August 1, and total payment is due by October 1.
- ☐ Total tuition payments for the 2026-2027 school year are due by October 1.
- ☐ **Late fees** will be assessed for any tuition not received by the end of business day on October 1, 2026. A \$25 fee will be added to your family account for each month that payments continue past due.
- ☐ **Withdrawal:** There will be no refunds on the Registration Fee, Supply/Lab fees, Class Fees or on the first tuition payment for classes dropped after May 31. Refunds will not be issued after July 31. This withdrawal policy is in place to help our instructors properly plan and budget for their school year.
