- Net Income Walk March 2025
 - o General Fund giving continues to be a negative trend
 - o March 2025 compared to March 2024 we are down 21%
- Parking Lot is happening, Furnace Replacement is happening and Air Compressor is on hold for now but likely to happen
- Finance Team Recommendation Discussed
 - Motion: Move the Antioch gift from the General Fund to our Hope Fund with the intent of using this for a long-term goal, or short-term if approved by SPC, to support the salary of the new Senior Pastor.
