Meeting called to order at 4:08 PM

REPORTS:

*Approval of last month's council minutes. Jen moved, Kelly 2nd, Approved

*Pastor's Report. Reviewed and filed.

*Treasurer's Report. Reviewed and filed.

BUSINESS:

Kathy Thompson joined us to discuss the St John's Playground improvements. She is excited to move forward. She knows as people see progress happening with the improvements it will energize folks. She noted the money needed for the architect work is already in the playground account.

- 1. The playground redo will take time. Kathy estimated that once the plan is approved and put in place it could take up to 52 weeks to finish.
- 2. Samatha Price (sp?) at Ritland+Kuiper Landscape Architects was here to look survey, look around and ask questions. Kathy is waiting for their plan. Does not have a timeline for this.
- 3. There was talk of relocating the existing playground across the parking lot next to the church. That was talk and the last idea was to leave it where it is and work the plan from there. One thing IF the PG was moved it would let the children play in the current PG at the same time the new one is being built. Still the overall thought was to keep the PG where it is.
- 4. Kathy wishes are for a poured in place surface, astro turf, a large climber item, a shade structure, a one child spinner wheel, no sand box in the PG have this in the garden, giant dish that swings, a merry-go-round to sit/stand/lay on, a zipline, something like they have a Ninja U.
- 5. Also hope to overhaul the Garden. Have a water table, mud kitchen, sand box with utensils and sculpting items, a fence 6' tall (that kids can't climb) with the gate that faces the sidewalk, continue to use the music wall and the planted areas could shrink.
- 6. 3 year olds are having potty accidents on the playground. Any way there can be a Porta Poddy by the PG to help minimize this?
- 7. Place cameras to maximize security as needed.

Scott Wirtz joined us to discuss Reconciling In Christ.

- 1. At this point the draft is done and edited, looking for Council's feedback.
- 2. From Scott's video shown at church on 11/12/23, verbal comments to him have all been favorable. He said there was one person who would not shake his hand or speak to him at the 'peace be with you' part of the service.
- 3. PJ wondered how we can open more dialog with RIC. Jen said people who write a snide comment most likely will not verbalize it to anyone.
- 4. We discussed making sure we communicate how the financial contribution can be made yearly to RIC so that is totally understood. Scott has asked the RIC headquarters what they expect in the form of this annual financial gift. Their response will be added to the communication we provide to the congregation.

- 5. Timeline RIC team is thinking the written communication is done and distributed in December 2023. The overall vote could happen at the annual meeting 4/28/2024. Or this vote could be done sooner on March 24 or 31, 2024.
- 6. FYI Colby Martin, author of the book Un-Clobbered (that the RIC team is reading), will be at St John to speak on 4/7/2024.
- 7. The Council will do an email review of the written RIC communication prior to it being released in Dec. 2023 or Jan 2024.

These will be moved over to the Faith Formation budget.
