## How We Seek to Make Counseling Available to All

Thank you for considering the Life | Works counseling ministry of St. Peter's. It would be our privilege to walk alongside you. We do not want finances to hinder your ability to receive the care and support you need. We offer the following to make counseling possible.

### Lower Standard Fee

The Standard Fee for our counseling services is lower than many other local counseling options.

### Adjusted Fee Schedule

No one will be turned away from St. Peter's counseling ministry due to an inability to pay. You are asked to pay all or whatever portion of the standard fee that you are able. Be assured that our staff will work with you in the intake process to determine an adjusted fee that honors your financial circumstances. Please talk with your counselor if, at any time, your situation changes and your adjusted fee needs to be revised.

### Assist in Utilizing Your Insurance

St. Peter's is not a Medicaid provider and we do not bill insurance directly. However, if you have insurance, we will work with you so that you can utilize your insurance or health savings account. We can assist you in learning what your insurance covers and then provide you with a receipt for each payment that will have all the information necessary for you to submit to your insurance company. This will enable you to apply your counseling payment toward your deductible or to be reimbursed once your deductible is met, according to your plan. You may also utilize your HSA card for payment. It is important to check with your insurance company to see if they require pre-certification before you begin counseling.

We trust that God will provide the resources for St. Peter's to continue to make counseling available to anyone, regardless of one's financial circumstances. Your partnership in making this possible, to the extent that you are able, is greatly appreciated.
