



Get Ready For Kindergarten

This summer enrichment program is designed to prepare students to make a smooth transition into kindergarten by reinforcing skills such as proper pencil grip; letter, sound, and number recognition; and correct letter formation in handwriting.

PROGRAM DETAILS:

The summer kindergarten preparation class is a half day educational program lasting 4 weeks for students who will be entering Traditional Kindergarten in the fall. The educational program uses Fletcher's Place and Handwriting Without Tears for a hands-on approach to learning. The class has a 1 to 10 teacher to student ratio. Program hours are from 8:00 AM – 12:00 AM, Monday-Friday. Program dates are as follows: July 1 - July 26, **PROGRAM CLOSED JULY 4.**

Fletcher's Place:

Fletcher's Place for kindergarten is based on the approach that young children learn best by playing, moving, singing, and interacting. Fletcher's Place for Kindergarten includes game books, "Little Books" (developmental readers), manipulative materials, DVDs, card games and a host of small group, paired student learner, and whole class games. Students interact with the teacher, each other, and the characters on the screen as they watch the video in short (3 to 5 minute) episodes.

Handwriting Without Tears:

The Handwriting Without Tears® kindergarten program incorporates hands-on activities and multi-sensory teaching strategies that build good handwriting habits early. The teaching will engage students with music, movement, fine motor activities, and child friendly language.

CURRICULUM AND TESTING FEE:

\$75.00 per student (Nonrefundable) due at time of registration.

TUITION RATES:

1st Child - \$650.00 due by July 1st

A multi-child discount is not available for students enrolled in the Summer Kindergarten Preparation class.

CURRENT FBCS PRE-K STUDENTS:

RETURNED CHECKS:

FIRST BAPTIST CHRISTIAN SCHOOLS OF STOCKTON ENROLLMENT CONTRACT

1. I/We understand and agree that enrollment of my child in the Summer Kindergarten Preparation Class does NOT guarantee admission to FBCS's K-8 Program and that I must submit an additional application and meet the requirements for acceptance into the K-8 Program. My child's enrollment is dependent on my parental support of the school, its staff, and its policies.
2. I/We understand that the faculty and staff of FBCS will teach love and respect for the Lord Jesus Christ and obedience to Him.
3. FBCS's biblical role is to work in conjunction with the home to mold students to be Christ-like. On occasion, the atmosphere or conduct within a particular home may be counter or in opposition to the biblical lifestyle the school teaches. This includes, but is not necessarily limited to, sexual immorality, homosexual orientation, or inability to support the moral principles of the school. In such cases, the school reserves the right, within its sole discretion, to refuse admission of an applicant or to discontinue enrollment of a student.
4. ***I/We agree to pay our financial obligations and to conclude all required payments on or before June 1st. I/We agree that if our account becomes 15-days past due our child/children will not be admitted to class until our account returns to good standing.***

5. ***I/We agree that tuition is a 6 week program based on a 2-term billing cycle. The first payment is due on the first June and the second payment is due on the first of July. After the close of the 10th of each month, all past due accounts will be assessed a \$25.00 late fee. A \$25.00 service charge will be assessed for any and all returned checks and stopped payment checks. Accounts with two returned checks will only be allowed to remit payment by cash, cashier's check, money order, or debit card.***

6. It is agreed that FBCS reserves the right to expel any student if it is determined by the Administration to be in the best interest of either the student or the School. I/We also agree to pay for any damages to or loss of school property attributable to this student.
