FBCS TUITION RATES:

Tuition payments begin on August 1st. Payments received after the 10th of each month will be assessed a \$25.00 late fee.

K-8 Grades 10 Month Billing Cycle 1st Child \$499.00 per month 2nd Child + \$330.00 per month

PAYMENT SCHEDULE:

The tuition charged by First Baptist Christian Schools may be paid in one of the following payment options:

- 10 month payment plan payments are due beginning August 1st and ending May 1st.
- 12 month payment plan payments are due beginning July 1st and ending June 1st.

FBCS FEES:

Registration Fee -per student (Nonrefundable)

A registration fee is charged for each student every year at First Baptist Christian Schools and **is due at the time of registration**. This fee covers the administration costs of enrolling your child, membership in the Association of Christian Schools International (ACSI), and achievement testing fees. Registration Fee amounts may differ dependent on several factors. See below.

Before April 1, 2020 \$250.00 If registered from April 1 – May 31, 2020 \$325.00 If registered after June 1, 2020 \$400.00

<u>Kindergarten Testing Fee</u>: \$25.00 per student (Nonrefundable) A testing fee is charged for each kindergarten student who does NOT complete the Kindergarten Preparation Class and is due at the time of registration. This fee covers the administration of the kindergarten readiness test which determines class placement.

<u>K-5th Grade Curriculum & Program Fee</u>: \$245.00 (Nonrefundable) This fee covers the cost of consumables used each year and participation in various programs provided by the school. The Curriculum & Program Fee is due by June 1st.

6-8th Grade Curriculum & Program Fee: \$395.00 (Nonrefundable) This fee covers the cost of consumables used each year, participation in various programs provided by the school. The Curriculum & Program Fee is due by June 1st.

FBCS DISCOUNTS:

MULTILPLE CHILD DISCOUNTS:

The multiple child discounts shall apply only to the children of a single parent, guardian or married couple, who are from the same household and have the same home address.

MINISTERIAL DISCOUNTS:

Full-time ordained or licensed ministers who are in need of financial assistance should express their need in a letter to the FBCS School Board.

IRREGULAR ENROLLMENT:

Tuition will be prorated after the first month of the school year based on the time of enrollment by the accounting department.

FBCS POLICIES:

WITHDRAWAL:

A \$200.00 withdrawal fee will be charged when a student withdraws from the school after being accepted. If a parent/guardian wishes to withdraw his/her child, a withdrawal form must be filled out and submitted to the office. Monthly tuition is not prorated for students who withdraw after the 1st of the month.

PAYMENT:

All payments due to FBCS (including tuition, fees, and other charges) may be made by exact cash, check, money order, cashier's check, or debit card. A \$2 processing fee will be applied to all debit charges **under \$75.** FBCS **does not** accept credit cards.

RETURNED CHECKS:

Any check returned to FBCS for any reason will result in a charge of \$25.00 to the account of the check writer to cover fees and additional bookkeeping. After two returned checks payments may only be remitted by cash, cashier's check, money order, or debit card.
