If you haven't heard already, there is much cause for excitement as Lilly Endowment Inc. recently made a major announcement!

The Community Foundation of Pulaski County is pleased to announce our intent to apply for a \$750,000 Matching Fund Grant through the eighth phase of Lilly Endowment Inc.'s Giving Indiana Funds for Tomorrow (GIFT VIII). This grant is one of three funding opportunities available to us through GIFT VIII for which Lilly Endowment has allocated up to \$210 million to support Indiana's community foundations in their efforts to enhance quality of life across the state.

We will be able to use this Matching Fund Grant to further develop our unrestricted endowment, which over time will provide financial resources that enable the community foundation to respond to both present and future community needs. Lilly Endowment will provide \$2 for every \$1 contributed to the Community Foundation of Pulaski County's Community Grants and other unrestricted endowment funds during GIFT VIII's matching period, October 1, 2023, through December 31, 2025.

I'm just thrilled to bits to have this wonderful matching opportunity available for Pulaski County – just in time for #GivingTuesday! Speaking of which, this newsletter is chockfull of news and events. 

Five students from two area high schools have been named finalists in the Community Foundation of Pulaski County Lilly Endowment Community Scholarship process. The finalists are: Alexa Schultz from West Central High School, and Lily Bennett, Bianca Huizar, Maggie Smith, and Kelsey Wegner from Winamac Community High School. Each student is to be commended for earning distinction as a finalist for the prestigious scholarship. The scholarship provides four years of full tuition and required fees and up to \$900 per year for required books and equipment.

The Community Foundation will submit nominations to a committee appointed by Independent Colleges of Indiana (ICI) for final selection of the recipient in accordance with the criteria and procedures consistent with applicable law and the overall goals of the Lilly Endowment Community Scholarship program. The recipient selected by the ICI committee will be notified by mid-December of this year.
