Church Congregation Council Meeting Minutes

1. Call to Order

Council President Mike Dunavant called the meeting to order at 7:01 PM and confirmed a quorum

2. Devotions / Opening Prayer

Missy Hill led the devotion, reflecting on **Luke 17:11–19**, the story of **Jesus healing the ten lepers**, emphasizing **gratitude and faithfulness**. She encouraged council members to consider how often we, like the nine healed lepers, forget to return to give thanks when blessings come our way. The discussion centered on cultivating **thankfulness as a daily spiritual practice** and recognizing God's presence in ordinary moments of grace. Several members shared short reflections on ways they've recently experienced gratitude within the church community and their personal lives. Missy closed the devotion with a **prayer of thanksgiving**, asking God to strengthen the council's hearts for service and awareness of His ongoing blessings.

 - o **Monthly:** Net income favorable by **\$28,520**; expenses essentially flat to budget (about **\$78**).
 - \circ **YTD:** Total income favorable by \$39,858; expenses unfavorable by \$946 (technology support timing), offset by small personnel savings. Offerings are up \sim 10% YoY.
 - **Operating position:** YTD expenses exceed YTD income by **\$55,886**, but net is favorable to plan by **\$38,912**.
 - Mortgage Reserve: Balance \$312,492, covering ~25.8 months of P&I at ~\$12,124/mo (through October 2027).
- **Motion**: Rob Boyle moved to approve the consent agenda.
- **Second**: Missy Hill seconded.

5. Old Business

A. Proposed 2026 Budget - Final Pass

2026 Budget

Debbie Sexton summarized the final budget to present at the Annual Meeting: \$977,100 balanced plan; revenues $\sim 1\%$ above 2025 budget (and $\sim 3\%$ over current-year forecast); property/auto insurance increased $\sim 8\%$; discussion on **Bastion Point** IT costs and a potential PC leasing program (about \$4,400/yr if added) with further analysis to be led by **Gwen Newman and Markus Groener** (transition plan, servicing, replacement cadence). For 2026, line allocations can flex between office-equipment reserve and tech expenses as needed; budget impact is intended to be a wash.

2026 Budget Approval

- **Motion**: Cindy McClintock moved to approve the proposed **2026 Budget** for presentation to the congregation.
- **Second**: Markus Groener seconded.
- **Vote**: **V**Approved unanimously

Merit and Insurance Plans

The Executive Committee recommended offering staff the highest ELCA Portico plan option (Select Copay 2000) with employee choice among alternatives, and a 3.5% merit increase for full-time staff. Council discussed affordability (roughly +\$25–26k over 2025 forecast, driven mainly by healthcare and merit), concluding this year is not the time to cut staff compensation.

- **Motion**: David Schiller moved to approve a **3.5**% merit increase for ordained and full-time staff and to fund health coverage up to the **Select Copay 2000** plan
- **Second**: Missy Hill seconded.
- **Vote**: **V**Approved unanimously

B. Acceptance of 2025 Endowment Fund Distribution

- **Motion**: Rob Boyle moved to accept the full 5% (\$53,528.05) 2025 Endowment Fund distribution.
- **Second**: Cindy McClintock seconded.
- **Vote**: **V**Approved unanimously

C. Nominating Team Report (Council)

Slate of three to stand for Council (to be elected at the Annual Meeting): **Matt Greenshields, Carl Erickson, and Jane Huddle.**

D. Update on Epiphany Shines Campaign

Steering structure forming; **John Stapleton** (communications/commitment role TBD) and **Cheryl Ham** (special events) have agreed to serve; lead-gifts chair still in discernment. A short "teaser" presentation is planned for the Annual Meeting; a larger kickoff is envisioned for early **2026**.

Council will ask the congregation to authorize Council to allocate **any 2025 operating surplus** by **March 1, 2026** (rather than defaulting to unrestricted surplus).

- **Second**: Cindy McClintock seconded.
- **Vote**: **V**Approved unanimously

F. New Signature on Accounts

Update pending; need to coordinate **Town Bank** visit among Jim Huddle, Jennifer Edwards, and Debbie Sexton.

G. Update on Space Allocation Meeting (Faith Formation/ELNS/Quilters)

Ad hoc team recommended dedicating **Room 201** for ELNS students starting **2026–27**; ELNS will purchase adjustable tables (approx. **\$1,000 each**) from their reserves. Quilters are supportive of relocating to **Price Hall** with added storage (to be explored).

H. Kneeling pads for the communion rail

Update from Kevin - Worship team is proceeding with custom foam and sewn covers to match the sanctuary (prefer over off-the-shelf pads).

6. New Business

A. GraceInside Funding Requests (Rob McClintock)

To be considered with **Advent/Christmas** special offerings at the **November** meeting (percentage allocations).

- Prepare and mail **Annual Meeting letter** (target postmark no later than **October 28, 2025**); link budget via congregational email.
