### IMPORTANT INFORMATION

Gurnee Community Church (GCC) is committed to conducting its programs and activities in a safe manner and holds the safety of participants in high regard. GCC continually strives to reduce such risk and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this program must recognize that there is an inherent risk of injury when choosing to participate in recreational activities. You are solely responsible for determining if you or your minor child/ward are physically fit and/or adequately skilled for the activities contemplated by this agreement. ### WARNING OF RISK

Climbing walls are intended to challenge and engage the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury. Understandably, not all hazards and dangers can be foreseen. The very nature of using climbing walls is hazardous and risky, including, but not limited to, overexertion, slip and falls, loose and/or damaged artificial holds, being fallen on by other users, belay instruction or supervision, poor technique, carelessness, horseplay, premises defects and all other risks inherent to the use of climbing walls. In this regard, it must be recognized that is impossible for GCC to guarantee absolute safety.

### WAIVER AND RELEASE OF ALL CLAIMS AND LIABILITY AND ASSUMPTION OF RISK
