Dear Edwina Jr.- April 5, 6 & 7, 2019

Auditions are set for Sunday, Jan. 20-2pm & Monday, Jan. 21-7pm. A suggestion has been made to charge the schools for the matinee performances or to add a suggested donation of \$1 or \$2 per student on the invitation (which should be sent out in January). We may also consider inviting the public schools as this musical is not strictly Christian. If public schools reserve for the matinee, we may fill up more shows and need to consider a  $3^{rd}$  matinee. It was also suggested that we forego the Thursday night dress rehearsal as it seems to be a step backward after the full audience performance of Wednesday.

### Seussical-July 26-August 4, 2018

JaNelle Powers is set to direct. Janet Palmer will music direct, and Joshua Catania will be the show accompanist.

### V. New Business

Update 2019 CAC annual budget – additional income opportunities (building rentals, program advertisers, charge schools for matinees, any other ideas)

Colleen gave an update regarding the Finance Committee questions and ideas. Anything we can do to increase revenue would be helpful (ie. Additional advertising, building rentals, etc.). It was discussed that additional building rentals are not easy, but proactive efforts will be considered.

#### 2019-2020 season slate -

(Youth musical, Christmas offering, *The Living Passion* or youth musical, and summer musical)

After considering the difficulties of *The Living Passion*, from getting a full cast, to getting an audience, we decided to do a youth Easter musical instead ("Passion Jr"). We settled on the following titles for consideration: *It's all because of Jesus, Donkey Tales, The Easter Pageant At Mr. Pigg's Barbeque Emporium,* and *Good News from a Grave.* 

We discussed that even though the Spring show will be a youth Christian musical, the fall slot should <u>not</u> be a JR, because we have chosen to only do a JR every other season (and we don't want to go from *Dear Edwina Jr*, to *Seussical*, to another secular JR). We prioritize the Christian musicals, not the JRs. After eliminating a few, we settled on the following list for consideration: *Agape League*, *Happily Ever After*, *Not Your Average Joe*, and *Prodigal Son*. The summer musical was narrowed down to either *Wizard of Oz* or *Beauty and the Beast*.
