# III. Old Business – Review of events since our last meeting/Updates on progress Seussical- July 26-August 4, 2019

Very good show! Total attendance – 642, 40 people in cast (14 new people). The Chapel youth group raffled "Seuss" baskets at intermission and were very successful (raised \$700 after expenses); this was a nice opportunity for the patrons to see a Chapel connection! There was some shenanigans happening backstage by kids in this show, we will brainstorm ways to keep the kids out of trouble in the future.

#### "Fun in the Son" 2019 June 17-21, 2019

\*The final P&L was discussed (but not passed out) with the members [see other attachment]. Bottom line= +\$1,120.86, Final income=\$4,211.78 (registration fees + scholarship donations), Final expenses=\$3,090.92 (Show materials, crafts, props, food, shirts, etc). There were 49 campers (one sick-all-week-no-show, and one dropped midweek), 21 new to CAC, 2 new to camp, 26 returning campers. 10 Scholarships this year. The camper turn-out to church the following Sunday is so low that it seems to be anti-climactic and not an accurate depiction of the exciting week that occurred. We will consider having 1-2 campers give testimony instead of asking them to come and sing (Colleen can show a performance song during the slideshow instead).

# IV. Upcoming/Current events Agape League- October 18-20, 2019

There are 18 kids in the show (none from COTH, all from community). We will not hold a Thursday Dress Rehearsal; we will instead invite the Nursing Homes to a performance of their choosing for free. Colleen will create business cards for advertising (in addition to the postcards and posters). Makenzie and Jeanna are hoping to visit each of the 4 churches (Lakeland, Calvary, Southern Lakes of Elkhorn, Faith Baptist of Delavan, one child not attending a church) that the kids

in the show attend to plug the show. They will start at COTH with a "Moment for Mission" mention of the show. Jeanna and Makenzie will try to incorporate many things into their rehearsals to make it more than a show: Bible Lessons (10 minutes), Shout-outs using Fruit of the Spirit, invites to Praise and Worship Night & Kingdom Kids, and visiting the kids' churches.

#### It's All Because of Jesus-April 3-5, 2020

Donna will direct. Nothing to report at this time, audition dates will be set at the next CAC meeting.

## Wizard of Oz- July 24 - Aug. 2, 2020

We have been granted the rights. JaNelle Powers will direct, Janet Palmer will Music Direct, and Sara Johnson will be the show accompanist.

A list of churches (represented by cast and crew) in the program would be a nice gesture.

We would like to continue the "Moment for Mission" testimonies during the church service for CAC impact; Robisons, Schuerrs, McEneanys, etc. would be great candidates if they are willing.

Colleen will reach out to Evan Knutson to coordinate a dance presentation to be presented during a church service in the future. "If We are the Body" by Casting Crowns is the song to be used.

We'd like to add a spot on audition forms for HOME CHURCH:\_\_\_\_\_with a PREFER NOT TO ANSWER option as well.

We would like to seek more tech people to be trained on Lights and Sound. We will reach out to local High Schools and Colleges, plus parents of kids in shows.
