The site may be occupied by no more than one RV and two vehicles. A tent may be placed on the site in lieu of one of the vehicles. In all cases the RV, vehicle(s), tents, canopies and all other personal property must remain completely within the site and not infringe access to shared fire pits, your neighbor's site, or shared roadways. In the case of larger RVs where there is not space to park a tow vehicle between the RV and the road, only one vehicle may be parked on the site.
