County metrics

In less than 2 months, our outbreaks and outbreak related cases have dropped more than 80%. We listed no classroom-related outbreaks this week and total school outbreaks dropped from 50 and 241 cases to 4 and 20 cases.

Updated guidance

On March 8, Washington State Department of Health released <u>new guidance</u> for K-12 schools, child care, early learning, youth development, and day camp programs that begins March 12. You can find guidance for all these groups in one document. Updates include:

Masks

- Masks and physical distancing are optional, but DOH recommends you use them as tools to continue to help limit the spread of COVID-19.
- Masks are optional on school buses.
- Masks are required in health rooms.

Reporting

- Schools are still required to report cases and outbreaks and notify staff and high-risk students of exposure.
- We may request close contact information during an outbreak.

Isolation and Quarantine

- Quarantine is optional.
- Staff and students who test positive may return after 5 full days of isolation if symptoms improve and they are without a fever for 24 hours without fever-reducing medications.
- To return to school staff and students must wear a well-fitting mask during day 6-10 or test negative with an antigen or at-home test any day after day 5.
- If the staff or student can't wear a well-fitted mask and don't test negative, they must complete a 10-day isolation.
- Schools must notify staff and high-risk students of potential exposure.
- Schools must have a process to inform all students, staff and parents if they have cases
 or outbreaks in the school.

Vaccine updates

CDC recommends COVID-19 vaccine for everyone 5 years or older. Everyone 12 years or older should get a booster dose:

- 5 months after their second dose of Pfizer or Moderna COVID-19 vaccine.
- 2 months after their single dose of Johnson & Johnson COVID-19 vaccine.

Please refer families to clinics below that have Pfizer vaccine for all eligible ages. Many pharmacies and healthcare providers also have vaccines available. As masking becomes optional in schools, it's important to strengthen other layers of protection against COVID-19, like increasing vaccination rates. Currently only 22.7% of Pierce County children ages 5-11 are fully vaccinated.
