Happy Anniversary, CFC!

Catholic Finance Corporation (CFC) was formed in July 2000 by Archbishop Flynn as the result of research conducted by the Reserves Task Force in the late 1990s. This committee addressed the issue of loans and debt management associated with building projects in the Archdiocese of Saint Paul and Minneapolis (ASPM).

The funding source for creating CFC and its loan pool came from the Archdiocesan *Growing in Faith* capital campaign. Thus, CFC began managing the Community Growth Partnership Fund to provide individual loans to parishes, schools, and other Catholic entities. CFC assisted parishes with debt management but also grew to provide financial best practices in budgeting, financial reporting, and forecasting.

Paying It Forward

Income from loan interest furnishes funding for CFC services and "pays it forward" to benefit other ASPM entities, similar to the Bailey Brothers Building & Loan in the classic movie, It's a Wonderful Life. For CFC, the money is not "here;" it's in "that house" of worship and "that" Catholic school.

Here's an example: St. X Parish needs a roof. Interest payments to CFC from St. Y provide the dollars to invest in that capital repair.

In addition, the loan interest revenue allows CFC to provide pro-bono or low-cost services in the ASPM. Serving only Catholic institutions, CFC offers loan terms and advisory services with more flexibility and an intimate understanding of the Church and its many facets.
