Financial Highlights for November 2023

Year to date through the end of November, the church has received a total of \$189,640 in contributions and other income to support the operations of the church. Total operating expenses through October were \$171,277 for a year-to-date net gain of \$18,363.

Combining this \$18,363 net gain with the year-beginning operating reserves of \$39,956 gives the church a total liquidity of \$58,319.
