In the event the child needs medical care of any nature and in the event all reasonable attempts to contact us have been unsuccessful, we hereby authorize the Church and its agents, assigns, employees and volunteer assistants to secure the administration of any medical treatment or medication, and we agree to the hospitalization of the child and the administration or performance of such treatments, anesthesiology services, and surgery or other operations as in the opinion of the treating physician may be necessary for the health and safety of the child, and we further agree to be responsible for all charges arising out of such medical treatments and we save and hold harmless the Church and its agents, assigns, employees, and volunteer assistants from any claims for such expenses. We have disclosed either hereon or in an attachment hereto all known medical conditions, allergies, special medical needs, and other pertinent medical facts needed by a hospital or doctor not having access to the youth's medical history.

In the event the listed activity requires that the child be transported, we agree that such transportation shall be by a driver who has completed the Church's Insurance Statement for Transportation of Students in Privately-Owned Vehicles and we save and hold harmless the Church and its agents, assigns, employees, and volunteer assistants from any claims arising from the transportation of the child in connection with the listed activity.
