YOUTH WITH A MISSION, declares that the information and personal data provided to us shall be processed lawfully, fairly and in a transparent manner in relation to the data subject concerned; it shall be collected for specified, explicit and legitimate purposes; the data shall not be processed further in a way incompatible with such purposes, in accordance with article 89, section 1; the further processing of personal data for archiving purposes in the public interest, scientific or historical research purposes or statistical purposes shall not be considered to be incompatible with the initial purposes; the data shall be adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed, accurate and, where necessary, kept up to date.

Every reasonable step shall be taken to ensure that personal data that are inaccurate with respect to the purposes for which they are processed, are erased or rectified without delay.

Personal data shall be kept in a form which permits identification of data subjects for no longer than is necessary for the purposes for which the personal data are processed; personal data may be stored for longer periods insofar as the personal data will be processed solely for archiving purposes in the public interest, subject to implementation of the appropriate technical and organisational measures required by this Regulation in order to safeguard the rights and freedoms of the data subject (storage limitation); processed in a manner that ensures appropriate security of the personal data, including protection against unauthorised or unlawful processing and against accidental loss, destruction or damage, using appropriate technical or organisational measures.

When the Data Controller plans to further process the personal data for a purpose other than that for which it was collected, they will provide the data subject, prior to said subsequent treatment, information about the additional purpose and any additional information.

In the event that the Data Controller foresees the transfer of personal data to third countries, the data subject must be informed in advance.

In the event that the Data Controller makes computerized decisions or develops profiles with the personal data, the data subject must be informed in advance.

The data subject has the right to complain to the Supervisory Authority.

We will only transfer your data where obliged to do so by law, for accounting and tax purposes, or for reasons related to the service offered by the organisation under a service contract between the Data Controller and the Data Processor.

For reasons related to their particular situation, the data subject may exercise the right to **object to the processing** of their data by **YOUTH WITH A MISSION**, unless there are compelling legitimate grounds, or the exercise or defence of any potential claims.

You have the right to obtain without undue delay by the Data Controller, the **suppression (right to be forgotten)** of your personal data when no longer necessary in relation to the purposes for which they were collected or processed in any other manner.

The data subject shall have the right to obtain **rectification**, without undue delay by the data controller of any inaccurate personal data concerning them.

The data subject may request the Data Controller to **transfer** the personal data they have provided, in a structured, commonly used, machine-readable format, and to transmit them to other data controllers, without the initial data controller to which the data had been provided preventing the transfer, when consent has been given for processing your personal data for one or more purposes, Article 6.1.a, 9.2.a Article and Article 6.1.b.
