

MEXICO 2019 CONTRACT

Before filling out this contract... please read thoroughly. This is a contract YOU are agreeing to! It is mandatory that you agree with the following items in order to be a part of the Mexico Missions Trip. These are required because we believe that our lives should exhibit Christ-like characteristics as missionaries and ambassadors here at home, as well as on the mission field. By completing and signing this form YOU agree to the following:

- Active involvement in church activities
 - No illegal drug or alcohol usage of any kind before or during the trip (this includes marijuana use). Absolutely no drug or alcohol use during the trip, June 21st-29th, 2019
 - No criminal activity or accusations
 - Sexual purity in accordance to God's Word (1 Corinthians 6:12-20 & Romans 1)
 - Active reading of God's Word whether through personal study, 50-day devotionals (provided by Go, Inc.) or group study
 - Attendance at the Mexico retreat March 1st-3rd, 2019 (no additional cost)
