### To: Gateway Baptist Church

In consideration of the Church sponsoring or being involved with various functions with the participant during the calendar year, the undersigned parents/guardians and participants hereby:

- . (a) Acknowledge that involvement in and access to some or all of these activities may involve private or public transportation; and understand that these activities and transportation to and from them may involve some risks;
- . (b) Understand that unintended injuries and death may possibly result as a consequence of participation in such activities and transportation to and from them;
- . (c) Accept full risk and responsibility for the death of or injury to the participant or damage to the property of the participant arising from the functions or transportation of the participant to and from such functions;
- . (d) Waive any rights whatsoever that the undersigned and participant may have now or in the future against Gateway Baptist Church and, as applicable, its members, leaders, congregants or volunteers as a result of death or injury to the participant or damage to the property of the participant arising from the participation in the activities or transportation to and from them; indemnify and hold harmless release and forever discharge the Church, its staff, members, leaders, volunteers or congregants from any actions, suits, claims, demands whatsoever, arising from any negligent, wrongful or illegal act or omission of the participant.
- . (e) Agree and understand that this document will be binding on the heirs, executors, administrators and assigns of the undersigned parents/guardians and the participant;
- . (f) Please and allow pictures of my child(ren) to be used for the sole use of Gateway Baptist Church for bulletins, notice boards, and the Church Website and/or social media;
- . (g) Behavioural conduct will be one of respect to leaders and other participants; respect towards property and facilities; will not participate in bullying or swearing; will bring in no illegal

substances or alcohol; will not bring or use media containing items not suitable or in agreement with Gateway Baptist Church's beliefs;

- (h) In the event that the participant's conduct is questionable, harmful or in breach of Gateway's standards or the facility's standards, the parents/guardians will be responsible for the cost of all damages occurred during the event, and will pay all costs related to transporting the participant home from the location of the event; and the parent/guardian will make arrangements to promptly pick-up their child from the event.
