I understand that I have enrolled my child in St. Wilfrid's Episcopal Preschool (California Department of Social Services Lic. #300600919). I do not have a guarantee of any particular teacher, classroom or schedule. It is at the Director's discretion to place my child according to his/her age and needs. Sibling discount is 10% off tuition for each additional child. Registration requires an annual non-refundable and non-transferable registration fee of \$235 per child for preschool ages 2.0-3.11 and \$340 for pre-k ages 4.0+ (includes materials fee). Summer Camp is included in our annual registration fee. Registration fees are due at the time of registration in order to hold your spot. These prices are in effect through December 2021.

NOTE: Our instructional program begins at 8:30am. Children must arrive on-time and be picked up on time. 1 ½ hour rest-time is required for all full-day preschool & pre-k students. We are closed for standard holidays, which are listed on our yearly school calendar. If your child is out for any reason you will still be responsible for all tuition fees. No credit or vacation will be allowed.

UNIFORMS: All parents are responsible for the Uniform Guidelines, including purchasing school uniform(s). Required uniforms include forest green logoed shirts, navy or khaki bottoms, navy blue cardigan, sweatshirt and navy blue or black shoes. No open toed or colored shoes are allowed. Please see attached guideline. A fee of \$25 will be charged per day if you are not in compliance.

PRESCHOOL SUMMER CAMP: No field trips at these ages. Camp activity fee pays for extra weekly activities/supplies. Days attending in Summer Camp may be modified. However, you must be enrolled year-round.

TUITION: Tuition is a full ten-month billing cycle billed monthly, September – June. The invoices will be emailed to you on the 23rd of the prior month. A late fee of \$25 will automatically be added if not paid before the 6th.

I/We agree to the above tuition fees and guidelines. Vacation, sick days and holidays are not discounted. A two (2) week notice must be given to terminate your child's agreement and your tuition must be paid in full before leaving. Any legal collection costs related to enforcing this agreement will be incurred by the responsible party(s).

This document must be signed by all responsible parties. I have read this Registration and Tuition Agreement and I understand and agree to abide by its contents.
