To participate in both student ministry events organized by Journey Church, and/or use of property, facilities and/or services of Journey Church, I agree for myself and (if applicable) for my child, to the following:

1. I give the participant listed on this form permission to ride in a vehicle designated by Journey Church for various student ministry events/outings (only adults will be permitted to drive).
2. I understand that if early return home is warranted due to disciplinary concerns, I will provide transportation home for the participant or transportation will be at my expense.
3. I understand that it is my responsibility to safeguard personal property. I further understand that Journey Church will not under any circumstances be responsible for any property lost, misplaced, or stolen, either directly or indirectly. I further understand that such loss may or may not be covered under my insurance and that Journey Church does not carry insurance to cover any such loss of my personal property.
4. I understand that as a participant my child may be photographed or videotaped during normal activities and that these photographs or videos may be used by Journey Church, and I waive any rights to compensation/ownership.

5. In the event of an injury to the participant during Journey Church sponsored activities, I give my permission to Journey Church, or to the employees, representatives, or agents of Journey Church, to arrange for all necessary medical treatment, for which I shall be financially responsible. This temporary authority will begin on January 1, 2017, and will remain in effect until terminated in writing by me or December 31, 2017, whichever occurs first. Journey Church shall have the following powers:
 - i. The power to seek appropriate medical treatment or attention on behalf of me or my child as may be required by the circumstances, including without limitation, that of a licensed medical physician and/or a hospital,
 - ii. The power to authorize medical treatment or medical procedures in an emergency situation; and
 - iii. The power to make appropriate decisions regarding clothing, bodily nourishment, and shelter.

6. I acknowledge that participation in the activity may involve risk to the participant (and to the participant’s parent or guardians, if the participant is a minor), and may result in various types of injury including, but not limited to, the following: sickness, bodily injury, death, emotional injury, property damage, and financial damage. In consideration for the opportunity to participate in the activity described (the “activity”), the participant (or parent/guardian if the participant is a minor) acknowledges and accepts the risks of injury associated with participation in and transportation to and from the activity. The participant (or parent/guardian) accepts personal financial responsibility for any injury or other loss sustained during the activity or during transportation to and from the activity, as well as for any medical treatment rendered to the participant that is authorized by the sponsor or its agents, employees, volunteers, or any other representatives (collectively referred to as the “activity sponsor”). Further, the participant (or parent/guardian) releases and promises to indemnify, defend, and hold harmless the activity sponsor from and against all suits, actions, legal proceedings, claims, demands, damages, judgments, liabilities, interest, attorneys’ fees, costs and expenses of whatever kind or nature (collectively, "claims") for any injury arising directly or indirectly out of the described activity or transportation to and from the activity, whether such injury arises out of the negligence of the activity sponsor, the participant, or otherwise.

7. I understand that this is a general form to be placed on file in the Journey Church offices which the church may use when necessary. I also understand that for some student ministry events there may be additional forms to be used.

8. I hereby consent and give permission for me and the participant to participate in Journey Church sponsored events, and agree on behalf of the above minor to all of the terms and conditions of this agreement. By signing this Release of Liability, I represent that I have legal authority over and custody of the participant mentioned above. This document is governed by the laws of the Commonwealth of Virginia, and the assumption of risk herein is intended to be as broad and inclusive as permitted by law.

I HAVE READ AND UNDERSTAND THIS DOCUMENT AND AGREE TO ALL CONDITIONS HEREIN. BY SIGNING THIS RELEASE, I VOLUNTARILY SURRENDER CERTAIN LEGAL RIGHTS AS DESCRIBED HEREIN.
