**Behavioral Guidelines:**

These guidelines will help to ensure a successful outing for everyone involved.

1. Participant is to conduct themselves in a manner reflecting the values of MSCC
2. Participant is never to leave the area where the group or activity is without permission
3. Participant is to be aware of and follow instructions given by adult leaders/sponsors

Failure to follow any of these guidelines will result in one or all of the following:

1. A loss of privilege for the remainder of the trip or activity
2. An additional disciplinary responsibility to be carried out for the remainder of the trip or activity
3. A phone call home (regardless of hour) to discuss the situation with the parent(s)/legal guardian
4. The sending of the participant home before the end of the trip or event at his/her own expense

**Legal Release and Permission Agreement:**

I, the participant, or for those under 18, the parent or legal guardian of the participant listed on this form, certify that he/she has my full approval to participate in any event organized by Main Street Christian Church (MSCC). The individual identified on this form understands that all participants are required to abide by the guidelines detailed on this form and responsible to the adult sponsors. MSCC assumes responsibility for discipline at its events and, if necessary, may, because of misconduct or disobedience, require a participant to leave. In such instance, I will assume full responsibility for returning the participant home.

Further, I hereby release, forever discharge and agree to hold harmless a) Main Street Christian Church and its ministers, directors, sponsors, and all other persons or entities acting on their behalf (the "Covered Parties") and b) the lessor/owner of properties on which the MSCC events are held, from any and all liability, claims, or demands for personal injury, sickness or death, as well as property damages and expenses, of any nature whatsoever which may be incurred by the participant, the undersigned, and/or any member of the participant's family by reason of participating in any activities associated with MSCC whether or not such claims, actions, demands, liability, costs or expenses are caused by the negligence or omission of any of the Covered Parties. It is my intention to, and I do hereby surrender and waive any rights to sue or exercise any legal right to seek damages from the Covered Parties from their failure to use reasonable care in any way.

Further, I do authorize the minister or sponsor of MSCC, or any MSCC staff member to take the participant to a doctor or hospital and I hereby authorize medical treatment, including but not limited to emergency surgery or medical treatment, and I hereby assume financial responsibility for all expenses incurred for such treatment and, if necessary, all expenses to return the participant home.

Further, I hereby assume all risk of personal injury, sickness, death, damage and expense as a result of the participation in any MSCC event. I hereby release and agree to hold harmless and indemnify the Covered Parties, for any liability and/or expense sustained as the result of negligent, willful, or intentional acts of the participant, including damages to the MSCC facility. I agree to pay for damage done to any MSCC facility or property by the participant.

For valuable consideration received, I hereby irrevocably grant to MSCC the worldwide, royalty-free, right to use the participant's name, voice, likeness, and image in all forms and media, and in all manners for any lawful purposes, commercial or noncommercial.

I acknowledge this agreement is intended to be as broad and inclusive as permitted by the laws of the State of Indiana and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. I further agree this agreement will be governed by and construed in accordance with the laws of the State of Indiana without giving effect to the principles of conflict of law and the courts within Indiana will be the only courts of competent jurisdiction. I hereby irrevocably submit to the personal jurisdiction of the courts of Howard County, Indiana.

I hereby certify that I have carefully read the foregoing and acknowledge that I understand and agree to all the above terms and conditions. I am aware that by signing this agreement I assume all risks and waive and release certain substantial rights that I may have or possess against MSCC or any of the covered parties.
